being discussed with the Canadian Legion. Carried
5. Tax Write-offs and Refunds - Moved by Aldermen Pescod  
and Leger that the tax write-offs and refunds  
as recommended by the Deputy Tax Collector be  
approved. Carried
6. Replacement of Permanent Employees - Moved by Aldermen  
Guindon and Lynch that the positions of Clerk-  
Typist at the Civic Complex and Bus Attendant  
at Cornwall Transit be filled on a permanent  
basis. Carried
7. Replacement of Permanent Employee - Moved by Aldermen  
T. Lalonde and LeBlanc that the position of  
janitor for the Kinsmen Municipal Centre be  
filled on a permanent basis. Carried
8. Cumberland & Eleventh Sts. - Moved by Aldermen Lynch  
and Pescod that Council not change its decision  
of March 5th that no physical or operational  
changes be considered for the intersection of  
Cumberland and Eleventh Streets until after  
the extension of Ninth Street from Cumberland  
to Brookdale is complete and opened to traffic. Carried
9. Walkway, Birmingham to Pitt - Moved by Aldermen Lebano  
and Aubry that Mr. Mayer be advised that no action  
will be taken on his submission until a final  
decision has been made with respect to all the  
alternatives available for the future extension  
of Sydney Street north of Thirteenth, inclusive  
of a decision on the land component that has  
vested in the City for the past six years. Carried
10. City Flags - Moved by Aldermen Lynch and Leger that  
the matter be deferred until the next Council  
meeting. Carried

11. 1984 Equipment Leasing - Moved by Aldermen Guindon and R. Lalonde that the financing of the 1984 equipment requirements be awarded to the National Bank of Canada for a total lease value of \$197,224.56, plus a purchase option of \$20,000 at the end of the term for an overall gross payout by the municipality of \$217,624.56. Carried
12. King George Hotel - Moved by Aldermen LeBlanc and T. Lalonde that the Council supports an application to the Liquor Licence Board of Ontario by the King George Hotel for reclassification from a hotel to a tavern and has no objections to the closing of guest bedroom accommodations. Carried
13. Marleau Avenue Speeding - Moved by Aldermen Guindon and Wise that the maximum speed on Marleau Ave. between Iroquois Drive and Campbell Street be raised from 50 Km/hr to 70 Km/hr and that a copy of the Traffic Engineer's report dated July 24th be forwarded to the Police Commission for followup. Carried
14. Street Flower Vendors - Removed from the agenda and will be placed on the agenda for the next meeting of Council.
15. Cornwall Transit Building Roof Repairs - Moved by Aldermen T. Lalonde and Pescod that all additional materials as outlined in a report dated August 3rd from the Chief Administrator and amounting to \$9,377 be added to Tender No. 47-84. Carried
16. Cornwall Transportation Study - Moved by Aldermen R. Lalonde and Pescod that a by-law be passed to authorize the signing of the Client/Consulting Engineer agreement; that Council pass the resolution contained in a report dated August 2nd from the Chief Administrator; and that Council arrange to meet with the Steering Committee and the Consultant during the week of September 10th. Carried
17. Tender #49-84 - Moved by Aldermen LeBlanc and Lynch that the tender for the operation of the concession at the Cornwall Community Arena be awarded to Glen Vending at a monthly rental rate of \$1,290.50 and in the 36 month period total tender amount of \$46,458. Carried

- 18. Tender #50-84 - Moved by Aldermen Lynch and Guindon that the tender for landfill site services be awarded to Dibblee Construction at a total bid price of \$192,747.50. Carried
- 19. Guy Street - Moved by Aldermen Pescod and Myers that no action be taken at this time on the request for temporary paving in the 900 block of Guy St. Carried
- 20. Appointment to Police Commission - Moved by Aldermen Guindon and LeBlanc that a letter dated August 2nd from the Ontario Police Commission be received advising of the reappointment of B.E. Comrie for a further period of two years, effective July 9, 1984. Carried

By-laws - Third Reading - Moved by Aldermen Lynch and Leger that By-laws 127, 1982 and By-laws 64 to 68, 1984 as listed for third reading be taken as read a third time and finally passed. Carried

NEW BUSINESS

Signs - Moved by Aldermen LeBlanc and R. Lalonde that the City purchase signs for Neighbourhood Watch and Elderly Crossings and that the signs be installed where needed.

An amendment was moved by Aldermen Wise and Aubry that the matter of signs for Elderly Crossings be referred to Administration and the matter of signs for Neighbourhood Watch be referred to the Vandalism Committee. Carried
