The Regular Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen R. Aubry, F. Guindon, R. Lalonde, T. Lalonde, A. Lebano, A. LeBlanc, G. Leger, B. Lynch, E. Myers, J. Samis and W. Wise. Alderman Pescod was absent.

ADOPTION OF MINUTES

Moved by Aldermen R. Lalonde and LeBlanc that the minutes of the September 24th meeting of Council be adopted. Carried

Moved by Aldermen Guindon and Lynch that the minutes of the September 24th meeting of Committee of Council be adopted. Carried

COMMITTEE OF THE WHOLE

Moved by Aldermen Lebano and LeBlanc that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that Committee and that By-laws 77 and 78 be given first reading -

- By-law 77 - To appoint Kevin John Collins as By-law Enforcement Officer for St. Lawrence College
- 78 - To authorize signing of agreement with the Roman Catholic Episcopal Corporation of the Diocese of Alexandria-Cornwall (parking)

DELEGATIONS

1300 Montreal Road - Mr. Parent, store owner at 1300 Montreal Road, complained that as a result of Montreal Road reconstruction the off-road parking that had been available to motorists in front of his store has now been eliminated. He stated that he has been the owner of this store for 26 years and during all that time customers were allowed to park on the boulevard to do business at his establishment. Mr. Parent claims that as a result of the reconstruction his business has suffered substantially since traffic is now flowing at a higher rate of speed and hardly anyone stops any more at his store. Some members of Council questioned Mr. Parent on his loss of business.

It was then moved by Aldermen Lebano and Guindon that Administration prepare a full report on the area in question, to be included in the report a cost estimate of relocating the curbing and the possibility of perhaps having to extend the sidewalk to the road in front of Mr. Parent's store and that this report be filed with Council for its consideration.


NEW BUSINESS


1985 Budgets - Moved by Aldermen Wise and Leger that Department Heads prepare their 1985 budgets with a guideline of 4% increase. Carried
