April 28, 1987 7:30 p.m.

The regular meeting of Council met this evening when the following were present: His Worship, Mayor B. Lynch, Aldermen D. Aubry, T. Green, A. LeBlanc, D. Carr, G. Leger, C. Poirier, F. Guindon, C. Charlebois, R. Lalonde, B. Gallant, G. Grant and T. Lalonde.

PRESENTATIONS

- 1. Mrs Dorris G. Turner was presented with an award from the Provincial Government as a recipient of the Corps D'Elite Ontario "Regional Award" including a Provincial Lapel Pin and a City of Cornwall certificate recognizing her efforts in volunteer work. Mayor Lynch invited Mrs. Turner to also sign the Golden Book.
- 2. Alderman Gallant on behalf of the S.D.G. Historical Society presented Mayor Lynch with two sketches drawn by the late Bob Eadie representing Inverden House and the Woodhouse Museum. Mayor Lynch accepted two paintings and indicated that they would be prominently displayed at the Cornwall Civic Complex.
- 3. Alderman Guindon, as City representative presented to Mayor Lynch and members of Council a brochure prepared by the Cornwall REgional Airport entitled Past, Present and Future.

DELEGATIONS

Mr. Rob Patten - Southland Canada Inc.
 was represented by Mr. Murray Huffman.

Mr. Huffman thanked Council for the opportunity to provide additional information which includes the needs that this community has for this type of convenience store together with minimizing or attempting to eliminate the possible nuissance this type of convenience store might draw in the neighborhood in question. Mr. Huffman indicated that their marketing studies clearly indicate that this intersection can support another convenience store and it has a legitimate marketing ability. As for a convenience store becoming a nuissance, the delegation presented to Council, handouts on the efforts made by Southland Corporation to appoint its employees with proper care of the property including robbery and violence prevention booklets. Mr. Huffman also sigited a recent OMB order that praised Southland Corporation as a good Corporate company. At this point it was moved by Aldermen Guindon and T. Lalonde that this delegation be provided an additional five minutes to complete his presentation. CARRIED

Mr. Huffman concluded his presentation that by stating that intentions are for Shell Canada to continue using this property as a gas bay and it was made quite clear that with Southland being allowed to make use of this property as a convenience store that the intersection in question would be greatly enhanced by the extensive renovations the company would make. He also indicated that if a convenience store was not allowed on that property, that it was his understanding that Shell Canada would continue with its present use and had no plans to convert or dispose of this property in any other fashion.

Mayor Lynch thanked Mr. Huffman for his presentation and reminded him that this matter would voted by Council under Item 3 on the agenda communications.

DELEGATIONS - cont..

Mr. Stephen Renner -

Mr. Renner circulated to Council a list of objections his clients would have if this application for rezoning was approved. He indicated that his clients main objection was that the proposed zoning as Neighborhood Commercial would not be suitable for this area and is certainly out of character when you consider that the main use of the properties in the area is residential with the exception of the Hospital. He further indicated that there are several other convenience stores within two blocks of the subject property and it is quite obvious that the area is well served with convenience stores and an additional store would not service the area any better. Mr. Renner concluded his presentation by asking Council to abide by the Planning Advisory Committee's decision to deny the application.

It was moved by Aldermen R. Lalonde and Charlebois that report No. 1-1 (B & M Meat Market) subject site be rezoned through a site specific amendment to the MFR 20 Zone, to permit a meat/vegetable/foodstuffs market.

It was moved by Aldermen Green and Guindon that report No. 1-2 (Garth Taylor) the existing special uses 20 be extended North to include the subject property, being 244 Marlborough, the adjacent property to the South known as 236 Marlborough, and the balance of Cornwall General Hospital parking lot to a depth of 175 feet from Marlborough St., therefore being in line with the depth of the lot for 236 Marlborough Street; and That the subject property be brought under Site Plan Control.

7. Non-Moving Violations

It was moved by Aldermen Green and Carr that the attached by-law be approved to allow Traffic and Parking By-law Enforcement Officers to ticket all non-moving violations within the metered zones as defined in Schedule "A" of the Parking By-law 104/77 and; that the By-law become effective May 15, 1987, preceded by advertising advising the public of the proposed changes in enforcement.

8. Loading Zone (165 Montreal Road)

It was moved by Aldermen Charlebois and LEBlanc that a loading zone for Commercial vehicles only be established in front of 163 Montreal Rd., on the south side of the roadway. This will require the removal of two on-street parking meters (agree to by Le Village) and the existing loading zone on the north side in front of 166 Montreal Rd. be removed and replaced with one metered parking stall; and a No Stopping zone be established on the south side of Montreal Rd. from the corner of Arthur Street to a point 15M further west.

9. Heavy Truck Parking Restriction

Moved by Aldermen LeBlanc and R. Lalonde that the City pass a by-law to prohibit the overnight parking of heavy vehicles on streets within residential zones (hours - 11:00 p.m. to 8:00 a.m.), That residential zones be defined for the purposes of this by-law as all areas identified by the Zoning By-law as R-10, R15, R20, R-30, R-40, as well as additional areas identified in Schedule "A" of the by-law to be prepared; That signs be erected at all entrances to the City indicating the overnight parking restriction for heavy vehicles. That monitoribe continued to determine if more restrictive measures are required should the problem not be rectified to a satisfactory degree.
