### ADOPTION OF THE SPECIAL BUDGET AGENDA

Moved by Councillors Glen Grant and Naresh Bhargava to adopt the Special Budget Agenda as presented.

### DISCLOSURE

Councillor Denis Moquin declared an interest TO Report #1, Cornwall Community Police Service citing that a family member currently is presently employed by the Service.

### REPORTS

*Having declared an interest in this matter, Councillor Denis Moquin stepped away from the meeting.*

#### 1. Cornwall Community Police Service

Chief Daniel Parkinson, accompanied by Deputy Chief Dan Aikman and Rolland Lefebvre, Treasurer, detailed to Members of Council, issues surrounding current and ongoing legal costs which will be incurred as a result of their ongoing work surrounding the Project Truth Inquiry. Chief Parkinson requested Council's endorsement in setting up a working reserve that would pay for the legal costs identified, to an upset limit of \$750,000 .

It was then moved by Councillors Leslie O'Shaughnessy and Glen Grant that a "Legal Cost Working Reserve" be established in the amount of \$750,000 for the purpose of paying legal costs that may be incurred as a result of the Project Truth Inquiry .

Chief Daniel Parkinson continued his presentation and briefly spoke about the Cornwall Community Police Service 2006 Budget.

It was then moved by Councillors Jacques Lemire and Joël Côté that Council accept a reduction of \$135,000 to the Cornwall Community Police Service Budget.

Chief Daniel Parkinson concluded his presentation by informing the Council that he would be seeking endorsement to a By-law at the next Regular Meeting authorizing the City and the Cornwall Community Police Service to enter into an Agreement with the Ministry of the Attorney General regarding a provincial grant for extra Police Officers.

## **ADMINISTRATIVE 2006 BUDGET REDUCTIONS**

### **1. Clerk's Services - Marriage Licence Fees**

Moved by Councillors Naresh Bhargava and Jacques Lemire that the Clerk's Department's budget identify an increase in revenues by \$8,500 generated by the sale of Marriage Licences .


