

CITY COUNCIL NO. 11-71

May 10, 1971.

A Regular Meeting of City Council was held this evening with the following members present: His Worship Mayor N. Kaneb, Aldermen L. Gauthier, R. Carrara, A. Clement, R. Brunet, D. A. Fawthrop, D. Webster, F. Guindon, G. Cameron, K. Bough, A. M. Lebano, J. Pescod and M. Holden.

DELEGATIONS

Mr. & Mrs. Lucien Lavigne - Mr. and Mrs. Lavigne were present this evening on behalf of their application, as set out in their letter, listed as number one on tonight's agenda.

Mayor Kaneb advised that Council would only refer the request to the Cornwall Planning Board and, possibly, they would wish to wait until the Board meets.

Irvin Brown - Mr. Brown submitted to Council, a proposal, whereby he is prepared to install 60 units on Fennell Crescent under the H.O.M.E. Plan. Mr. Brown advised that the development will take 30 lots of 42 lots owned by him in this subdivision. He submitted, in writing, estimates of total costs for servicing the land with amounts to be borne by himself and other property owners which leaves a balance of an estimated \$7,500 to be paid by the City.

Moved by Alderman Cameron, seconded by Alderman Clement that the City pay an amount up to \$7,500 for servicing the 30 lots. The motion was withdrawn.

Moved by Alderman Pescod, seconded by Alderman Fawthrop that the request be referred to the Public Works Committee. The motion was withdrawn.

Considerable discussion ensued as members of Council seemed receptive to Mr. Brown's proposal but were aware that the Public Works Committee does not have the necessary money in its budget.

Mr. Brown stated that, if necessary, he would be prepared to wait until next year for the City to pay its share.

Alderman Brunet was advised that, if Mr. Brown is paying cash for the services, then the work would not be under the Local Improvement Act but, if a charge is to be levied against the property owners on a deferred or cash basis, then a petition would be necessary.

It was then moved by Alderman Clement, seconded by Alderman Lebano that Mr. Brown's submission be studied by the Public Works and Finance Committees at a meeting to be held this Thursday at 6:30 p.m. Unanimously adopted.

Adoption of Minutes - Moved by Alderman Carrara, seconded by Alderman Gauthier that the Council minutes of meetings held April 26th, April 28th and May 6th be adopted as received. Unanimously adopted.

Referring to Committee of the Whole minutes No. 9-71, Alderman Bough stated that it was not recorded that he left his chair and refused to take part in the discussion on salaries.

Alderman Holden suggested that, if Alderman Bough did not agree with the actions of the Committee, he should have voted against the motion and then handed in a minority report.

6. Minister of Social and Family Services - Ontario Senior Citizens' Week - Moved by Alderman Clement, seconded by Alderman Lebano that the Mayor be authorized to proclaim the week of June 20th - 26th as Senior Citizens' Week. Unanimously adopted.

7. Township of Cornwall - Refuse along Cornwall Centre Road - Moved by Alderman Gauthier, seconded by Alderman Pescod that the letter, with attached resolution, be referred to the Public Works Committee. Unanimously adopted.

Alderman Carrara praised the 15 boy scouts who helped clean up the litter during the Miles for Millions march. He noted that 200 bags of garbage had been filled by the scouts.

Mayor Kaneb also commended, not only the boy scouts but everyone who had participated in the walk. Alderman Carrara suggested that, should the walk be held next year, no one be permitted to sell food in between the check points, as a great deal of litter was caused by this practice.

8. Department of Consumer and Corporation Affairs - Tender information - Moved by Alderman Guindon, seconded by Alderman Holden that the letter be filed. Unanimously adopted.

9. Niagara Grape & Wine Festival - Grande Parade - Moved by Alderman Webster, seconded by Alderman Brunet that the letter be filed. Unanimously adopted.

10. Child Welfare Branch - Children's Aid Society - Moved by Alderman Fawthrop, seconded by Alderman Carrara that the

Minister of Social and Family Services be asked to refer to the Child Welfare Review Committee, the question of amount of payment to be made by the City to the local Children's Aid Society. The motion was withdrawn.

The Administrator read correspondence, forwarded by Mr. Hamilton to the Child Welfare Branch, which resulted in this letter of April 30th. Mr. Fennell explained that, under a recent amendment to the Child Welfare Act, a municipality must ask for a hearing, otherwise it is deemed to have accepted the amount as requested by the Children's Aid Society.

After some discussion, Council recommend that the Mayor ascertain as to whether the City would be responsible for the costs if a hearing is requested and, if so, what the costs might be.

#### NEW BUSINESS

Reports in Local Press - Mayor Kaneb gave a prepared statement, under today's date, referring to recent articles and editorial in the local press, in which criticism was levied against the Police Department in an incident which took place at

822 Bedford Street on May 5th. The Mayor stated that, after receiving a report from the Chief Constable, he would like to state that he is completely satisfied with the actions taken by the Chief Constable and his men in this incident. He added that, as this matter is before the court, it is not proper nor appropriate to release the Chief's report at this time.

Tax Rebate - Alderman Gauthier referred to the many phone calls he has received from tenants, complaining that they are not receiving the tax rebate. He was advised that the municipality is required to deduct the amount of the rebate from the tax bill. Any other direction is from the Provincial Government, not the City and, in this respect, the Department of Municipal Affairs is expected to place a notice in the local press advising tenants that they are entitled to this rebate.

Keeping of Horses - Alderman Carrara asked that the Public Works Committee make the Health Unit aware of the deplorable condition in the area of McConnell Avenue, Morris Street and Gerald Street where horses are kept in the backyards. He stated that this area needs cleaning up as there are three outdoor toilets and no septic tanks and eight buildings should be torn down.

Loblaws Groceteria - Alderman Carrara reported that garbage has been permitted to accumulate at the rear of Loblaws Store. This matter has been reported to the Health Unit.

Water Sprinkling - Alderman Carrara referred to the very hazardous condition created by the City water trucks driving along Second Street east at 8:00 o'clock in the morning. He pointed out that it is very difficult to drive into the sun as it reflects onto the watered streets and suggested that maybe, the sprinkling

could be carried out in the evening.

Tax Rebate - Alderman Brunet stated that, possibly, the best advice to be given to landlords if they feel rent should be increased is that they must pass the tax rebate on to the tenant and, if they feel the rent should be increased, then they should advise the tenant to this effect.

Oil Slick - Alderman Brunet complained of oil on the water in the canal at the foot of Augustus Street which was especially noticeable this past week-end. He asked that the Anti-Pollution Committee look into this problem.

Drilled Wells - Alderman Brunet suggested that the City have some kind of by-law with respect to drilled wells. He referred to the area on Montreal Road and the Jules Motel. He pointed out that a gentleman, who owns a lot in that location, has been advised by the Health Unit that he cannot put in a septic tank as this would only contaminate the water of the adjoining neighbours who have hand dug wells. Alderman Brunet felt that people in this area should be required to install only drilled wells.

Flooding on Miron Street - Answering Alderman Brunet, Mr. Adams stated that it should be around September when he is in a position to present a full report to Council on the problems encountered in the Miron Subdivision.

Building on Albert Street - Alderman Brunet referred to the poor condition of a home on Albert Street which is owned by the Pants Factory. Mr. Adams reported that the building is structurally sound and, therefore, the City would be unable to have it demolished. However, he went on to state that he has

recently spoken to the Industrial Commissioner and believes that some action will take place very shortly.

Pavements - Alderman Brunet suggested that a notice be inserted in the local press that there will definitely not be any pavements constructed in 1971 as work of this nature has not been allocated in this year's budget. Mayor Kaneb indicated that a crash program on storm sewers is now being undertaken in order that pavements may be constructed next year. Answering Alderman Brunet, the Mayor stated that there are no storm sewers in the Danis Avenue area and many other sections of the City.

Tenth Street and McConnell Avenue - Alderman Brunet referred to the break-up of the gravel road in the City's industrial area at the corner of Tenth Street and McConnell Avenue. In his opinion, the road should be improved in order to carry tractor trains, etc.

Miron Subdivision - Referring to the Miron Subdivision which was discussed earlier this evening, Alderman Clement stated that, in his opinion, the month of September would be too late to receive a report from the Engineer as it would be getting late in the year and the program could be delayed another year. He inquired as to how this work could tie in with the program of the Conservation Authority at Gray's Creek. He suggested that this problem could be brought to the Authority's attention when the Industrial Committee discusses with them, the acquisition of two parcels of land that they have indicated an interest in.

Alderman Clement suggested that a pump house be constructed if it is found that this is the only manner in which this problem can be rectified. Mr. Adams replied that the Engineering Department

will take until some time in July just to do the survey work and, if Council wishes this work, together with many other projects, undertaken at the same time, then it will be necessary to add consultanting engineers to the present staff. The matter was referred to the Public Works Committee.

Liquid Calcium - Alderman Clement inquired as to whether calcium or oil is being used on the streets. Mr. Adams stated that he is presently making arrangements for an application of liquid calcium.

Courtesy Cards - Moved by Alderman Webster, seconded by Alderman Lebano that City Council recommends to the Parking Authority the placing of courtesy cards on cars from outside the province throughout the twelve months of the year. Unanimous.

Inverarden House - Alderman Webster reported that Honourable F. Guindon has indicated that money is now available for the restoration of Inverarden House and he expects to call a meeting in the near future.

Committee of the Whole Report No. 9-71 - Alderman Fawthrop stated that he was disturbed about the manner in which Committee of the Whole meeting No. 9-71 was handled. He pointed out that this question had been referred to the Finance Committee consulted and and he, inturn/with Mr. Boyer,/had come up with a recommendation which was approved by this Council by a 9-1 vote. The question of salaries was again brought up at a Committee of the Whole meeting on April 28th after the budget had been set, which minutes were approved in Open Council that evening. The vote, at that time, indicated that most members of Council had completely changed their minds. Alderman Fawthrop questioned Mr. Boyer as to whether he had used any influence to change the minds of

the aldermen. Alderman Fawthrop was ruled out of order by Mayor Kaneb.

Mayor Kaneb referred to paragraph two of By-law No. 861, 1970, especially the Clerk-Administrator's responsibilities which cover all matters relating to administration, labour relations, i.e. negotiations with the staff association, public works union, firefighters association, non-negotiated staff and Department Heads. He further referred to minutes of Committee of the Whole of March 9th wherein Council requested that the salary plan, in effect, be studied by the Finance Committee which is to present a report to the next meeting of Committee of the Whole. This motion was defeated and a motion was then adopted that the Clerk-Administrator submit a complete report at the next Committee of the Whole meeting. He also brought out the fact that, on March 22nd in Committee of the Whole, there was a motion that the report, covering increments to certain employees under the non-negotiated salary plan, be referred to the Finance Committee. This motion was withdrawn and the Administrator was then asked to present information covering all municipal employees with the plans to be reviewed at the next Committee of the Whole meeting. At that time, the Mayor indicated that he is prepared to call a special meeting to study these plans if it is deemed necessary.

Mayor Kaneb then followed through to state that Council, in a Committee of the Whole meeting on April 26th, received a report from Mr. Boyer that the Negotiating Committee would like to meet with Council in Committee of the Whole to study negotiations, to date, with C.U.P.E., Firefighters Association, local 849 and also the salaries of all non-negotiated staff and Department Heads. The

Committee, at that time, recommended that a special Committee of the Whole meeting be held on Wednesday, April 28th at 7:30 p.m. Therefore, the Mayor stated, that Council is right in dealing with this matter, based on the above facts. Further, no one objected to this procedure.

Insurance Claims - Alderman Guindon referred to the damage done to homes on Dunkirk Street and Vimy Avenue, as a result of work carried out on the Sydney Street extension.

Mr. Adams related that he has experienced some problems with the program carried out by the O.W.R.C. and noted that the Provincial Government has indicated that it is going to carry out an investigation with respect to insurance claims. Alderman Pescod was asked to work with Mr. Adams to look into this proposed investigation and, if necessary, prepare a brief on City claims.

Standard-Freeholder Employee - Mayor Kaneb reported that Mr. Mac Johnson, the local press reporter, is moving to Guelph. The Mayor thanked Mr. Johnson for his efforts and faithful attention at Council meetings and stated that he hoped that, sometime, he will return to Cornwall as editor of the newspaper.

Highway No. 138 and Cornwall Centre Road - Alderman Guindon complained of the difficulty transports encounter on turning northerly on Highway No. 138 off of Cornwall Centre Road and suggested that the Department of Highways be asked to have the mouth of this road widened to that trucks will not have to turn on the boulevard.



Miron Subdivision - Alderman Guindon stated that the least expensive method and one that could help alleviate the problem in the Miron Subdivision would be to extend a pipe into the channel to take the water from the Fly Creek Sewer into the St. Lawrence River.

Thirteenth Street and Brookdale Avenue - Alderman Cameron referred to the aggravating situation that exists at Thirteenth Street and Brookdale Avenue where an improvement is needed to the traffic circle and also the installation of traffic lights. Mr. Adams recalled that, last year, the Public Works Committee had submitted a proposal for work to be carried out at this intersection along with other areas but the recommendations had been turned down by Council.

Committee of the Whole minutes - Alderman Cameron made reference to a letter referred to earlier this evening by the Administrator, which letter, he stated, had been read at the last Committee of the Whole meeting. Alderman Cameron noted that no reference to the letter was made in the minutes and, as he was not present at that time, was not aware that such had been received.

Youth Hostel - Alderman Bough reported that it seems almost certain that the Youth Hostel Committee will receive a provincial grant but, as yet, no suitable building has been found and he would appreciate it if anyone knowing of a building that could be used, to get in touch with him as they hope to commence operation by June 1st.

Procedural By-law - Alderman Bough reported that he recently gave notice to Council that he would like to present a new procedural by-law and, since that time, has done a fair amount of research on this project and hopes to present a new by-law very shortly,

at which time, a copy will be made available to each member of Council.

Miles for Millions - Alderman Lebano referred to the tremendous job carried out by the scouts during the walk and felt that it was very pleasant to hear the singing and comments made from these youngsters who participated. He recommended that a letter of appreciation be sent to the boys.

Proposed City Parks - Alderman Lebano referred to the proposed park areas behind Courtaulds, in the Riverdale area, Lemay Street, Optimist Park on Ontario Street, development of the Gray's Creek area and Wayside Park. He asked that the Engineering Department submit plans to the Parks and Recreation Committee in order that the citizens may be aware of the many park developments.

Drug Costs - Alderman Lebano recalled that Council had previously considered the high costs of transportation from one point to another. He felt that Council should now look into the high costs of products especially charges made for drugs.

Senior Citizens - Alderman Lebano referred to the very small monthly increase given to senior citizens, living on a pension. He pointed out that the members of Parliament had recently received a substantial increase in salary and felt that more consideration should be given to our elderly citizens.

Flooding at Adult Training Centre - Answering Alderman Lebano, Mr. Adams stated that the storm water at the Adult Training Centre is going back into the system and there is no problem at this time with flooding.

City Council Meeting - Due to Victoria Day, Council recommends that the next meeting of City Council be held on May 31st.

Old Streetcars - Mr. Boyer reported that an answer to our letter of April 30th had been received from C.N.R., indicating our interest in obtaining one of the old streetcars to be used as a museum piece. A copy of the letter is to be made available to Alderman Webster.

Agreement for Transit Service - Mr. Boyer reported that Mr. Fennell had been advised that the Private Bills Committee of the Ontario Legislature will hear the City's application for an act respecting the City entering into an agreement with A. J. McDonald for the operation of the transit system. Alderman Pescod, he stated, will represent the City at the hearing.

1971 Census of Canada - Mayor Kaneb reported that he has received from the Director of the Census Division, Dominion Bureau of Statistics, news release with a draft proclamation. A copy of the release is to be made available to members of Council and the news media.

Tree Planting - Mayor Kaneb reported that tree planting is to be again undertaken this week on Cornwall Centre Road, similar to the project carried out last year at the Filtration Plant. He felt that, within three or four years, the City should have sufficient trees available and will not have to buy any.

Adjournment - Moved by Alderman Gauthier, seconded by Alderman Guindon that Council adjourn into Committee of the Whole.

Following a meeting of Committee of the Whole, Council reconvened.
