

CITY COUNCIL #20-72

July 3, 1972.
7:00 p.m.

A Special Meeting of City Council was held this evening when the following members were present - His Worship Mayor E.C. Lumley, Aldermen G. Leger, A. LeBlanc, G. Samson, A. Clemen, D. Webster, G. Cameron, K. Bough, A. Lebano, J. Pescod and M. Holden.

DELEGATIONS-Pavement on Danis

Mr. Fern Gadbois headed a delegation appearing before Council in support of their petition for a pavement on Danis between Second and Third Streets. He related the history of the development of the area and in so doing stated that the first petition had been submitted in 1967. In 1970 another petition had to be submitted as the first one was no longer valid. After this year, another petition would be required.

Mr. Lazette, also a resident of Danis Avenue, asked that if Lasalle Road was not being paved this year, if the money for this project could not be used to do Edythe and Danis Avenues.

Mr. Adams advised that Lasalle Road will be paved between Guy and Carleton Streets and that the City would end up being \$8,000 over the amount budgeted for pavements.

Alderman Pescod stated that residential streets are paved in the order in which petitions are received, and that Danis Avenue is at the top of the list if residential paving is done in 1973.

Mr. Adams pointed out that prior to the beginning of construction another petition would be required merely to back up the first petition in case properties have changed ownership since the original petition was circulated.

Alderman Lebano also reminded the delegation that sometimes expenditures are forced on a municipality which means curtailment of certain municipal services.

It was also brought out that more residential pavements were constructed this year than in any year in the past six years.

Adoption of Minutes

Moved by Alderman Leger, seconded by Alderman Lebano, that the Council minutes of the meeting held June 26th be adopted as received. Carried.

Alderman Lebano advised that he had met with Messrs. Tremblay and Leger of St. Lawrence College and all areas of misunderstanding have been cleared up. The courts will be available for use very shortly. He expressed his thanks to Messrs. Leger and Tremblay for their acknowledgement of our request and for their co-operation.

Alderman Lebano stated that he was surprised that no one had approached him about the statement he had made at the last meeting of Council with respect to some properties being assessed for very little and selling for considerable sums.

Mayor Lumley advised that the matter would be discussed in Committee of the Whole.

PETITIONS

PE #27-72 - Menard Bros. & others - Storm Sewer on Iroquois from Marleau to Lot 228

PE #28-72 - Menard Bros. & others - Pavement on Iroquois from Marleau to Lot 228

Moved by Alderman Bough, seconded by Alderman Clement, that the petitions be referred to the City Engineer. Carried.

REPORTS

Committee of the Whole #15-72

Moved by Alderman Lebano, seconded by Alderman Samson, that the report be adopted as received. Carried.

Parks and Recreation Committee #11-72

Moved by Alderman Lebano, seconded by Alderman Webster, that the report be adopted with the exception of the whole of paragraph 3 which is to be discussed in Committee of the Whole only. Carried.

Alderman Bough stated that he realized that the Hockey Clubs' expenses are going up, but then so are the City's. He suggested that the recommended gate split will cut the City's net to about half of last year's. He further suggested that any agreement with the Royals Hockey Club should be deferred until the City is in receipt of an audited financial statement for 1971-72 and a pro forma statement for 1972-73. Alderman Bough therefore made an amendment to the motion, which was seconded by Alderman Cameron, that the report be adopted with the deletion of the second last paragraph beginning with the words "After further discussion" and ending with the words "new contract negotiated", and that this section of the minutes be dealt with at a later date.

Alderman Holden stated that the Club had put forth a good submission with figures to back up their request. The Parks and Recreation Committee are aware of the City's decrease in net receipts; however, Mr. Miller has stated that there are areas where expenses can be cut down to offset this loss.

Alderman Webster pointed out that smaller towns are subsidizing their clubs; Cornwall is not but making money from gate receipts. A new contract will be negotiated at the end of the proposed agreement.

Aldermen Lebano and LeBlanc agreed that recent negotiations were the best experienced between the City and the Hockey Club.

When the vote was taken, the amendment was defeated and the motion carried with Aldermen Bough and Cameron voting against the motion.

Cornwall Planning Board #5-72

Moved by Alderman Pescod, seconded by Alderman Webster, that the report be received and adopted. Carried.

RESOLUTIONS

RE #58-72 - E.O.D.C. - Tourism and Industrial Pormotion

Moved by Alderman Webster, seconded by Alderman Clement, that the resolution of the Eastern Ontario Development Council, supporting statements made by Premier William Davis

and Honourable Darcy McKeough that regional planning should be a responsibility of the municipalities, and resolving to further assist in the creation and implementation of planning when called upon, be endorsed. Carried.

BY-LAWS

Moved by Alderman Pescod, seconded by Alderman LeBlanc, that the by-laws be read a first and second time. Carried.


