

CITY COUNCIL NO. 21-73

A Special Meeting of City Council was held today with the following members present: His Worship Mayor E. C. Lumley, Aldermen G. Leger, A. LeBlanc, G. Samson, D. Webster, D. Fawthrop, G. Cameron, K. Bough, A. Lebano, J. Pescod and M. Holden.

Excused from Meeting - Moved by Alderman Leger, seconded by Alderman Lebano that Aldermen A. Clement and F. Guindon be excused from attendance at this afternoon's meeting. Carried.

Report re Supply of Sand, Tender #27-73 - Moved by Alderman Pescod, seconded by Alderman Bough that the tender for the supply of sand be accepted as set out in the report of September 11th and recommended by Messrs. W. F. Ainslie and C. F. Adams. Carried.

Alderman Cameron suggested that, in the future, the Public Works Committee look into the possibility of using one company to supply the sand and spread it at the landfill refuse disposal site.

Report re Rental of Vehicles for Public Works and Recreation Departments, Tender #28-73 - Moved by Alderman Fawthrop, seconded by Alderman Pescod that the tender of Cornwall Chrysler Plymouth (1970) Ltd. be accepted in accordance with the recommendation contained in the report of September 11th submitted by

Messrs. W. F. Ainslie and C.F. Adams provided there are no additional vehicles being requested. Carried.

RE #75-73 - City of Cornwall

Moved by Alderman Lebano, seconded by Aldermen Leger that Alderman M. Holden and Mr. Dwayne Hollingsworth be authorized to vote on behalf of the City of Cornwall on such resolutions as may be put before the meeting of the Raisin Region Conservation Authority to be held on October 4th with respect to the enlargement of the Authority to include those parts of the St. Lawrence River, Lake St. Lawrence and Lake St. Francis within the corporate boundaries of the City of Cornwall, Township of Lancaster, Township of Charlottenburgh, Township of Cornwall and the Township of Osnabruck. Carried.

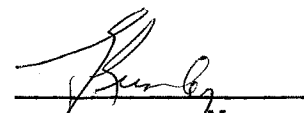
By-law No. 1521 - To amend Zoning By-law No. 751, 1969, as amended (parking requirements)

Moved by Alderman Holden, seconded by Alderman Pescod that By-law No. 1521, 1973 be given a First and Second and Third Reading. Carried.

Alderman Pescod explained that this amendment to the Zoning By-law was prompted by a request of W. G. Stevenson & Associates for a building permit to erect a Holiday Inn on Brookdale Avenue North. The company had appeared before the Planning Board on September 19th and 25th and a recommendation in accordance with this by-law was made by the Board to Council.
