

CITY COUNCIL - #18 - 77

May 30, 1977

The regular meeting of City Council was held this evening with the following members present - His Worship Mayor G. Parisien; Aldermen P. Armstrong, R. Aubry, G. Cameron, F. Guindon, L. Keen, L.G. Lavigne, A. Lebano, A. LeBlanc, B. Lynch, J. Pescod, G. Samson and G. Williamson.

Presentations - The Fire Chief presented Marc Grandmaison a certificate of Honourable Mention, on behalf of the Ontario Association of Fire Chiefs, as the result of the Fire Prevention Poster Contest.

Adoption of Minutes -

Moved by Aldermen Pescod and Cameron that the minutes of the Council meeting of May 16th be approved. Carried

Moved by Aldermen Lynch and Guindon that the minutes of the Council meeting of May 19th be approved. Carried

Moved by Aldermen Keen and Lebano that the minutes of the Committee of Council meeting of May 19th be approved. Carried

Lapierre briefly outlined the various events that will be taking place during the week of La Semaine Francaise to be held June 3rd - 11th 1977.

Alderman LeBlanc introduced a motion to allow for the use of the Cornwall Civic Complex for one free evening. Mayor Parisien ruled the motion out of order.

4. Tender #27-77 - Moved by Aldermen Williamson and Samson that Cornwall Chrysler Plymouth Ltd. be awarded the tender for two full size cars at a net total price of \$9,948.00. Carried

5. Tender #28-77 - Moved by Aldermen Lebano and LeBlanc that the tender of Elco Electric Ltd. be accepted for the supply and installation of lights /Fixtures/Service for two Tennis Courts at a total tender bid price of \$7,234.00. Carried

6. Ministry of Culture & Recreation - Moved by Aldermen Aubry and Cameron that the letter from Hon. R. Welch giving his approval to demolition of the Capitol Theatre, with no forfeiture of the grant, be received. Carried

7. Tender #26-77 - Moved by Aldermen Guindon and Samson that Gulf Oil Canada Ltd. be awarded the tender for the supply of gasoline/ Diesel Fuels and Furnace/Stove Oils in accordance with the report of May 17th of the Director of Public Works and Purchasing Agent. Carried

8. Tender #29-77 - Moved by Aldermen Guindon and Williamson that Miller Hughes Ford Sales Ltd. be awarded the tender for an Animal Control Vehicle at a price of \$5,648.00. Carried

9. Tender #30-77 - Moved by Aldermen LeBlanc and Samson that Hec's Tree Service be awarded the tender for Tree Cutting, Trimming & Stump Removal at a total price of \$3,275.00. Carried

10. Silver Jubilee - Moved by Aldermen Lynch and Aubry that Council approve a grant of \$500.00; that the S.D. & G. Highland Dancing Association stage a Silver Jubilee Dancing Championship on Labour Day weekend; and that the Cornwall Ministerial Association organize an ecumenical service - in accordance with the suggestions of the Arts Development Committee. Carried

11. Cornwall Bathtub Racers' Assoc. - Moved by Aldermen Guindon and LeBlanc that this Association be granted permission to hold a race in the waters adjoining the area fenced off for the boat tour management and being immediately south of the Air Force building, the event to take place on June 11, 1977. Carried

Council expressed its concern over the turbidity of the water in this area.

Committee of the Whole - Moved by Aldermen Lynch and Samson that the Committee of the Whole be adopted. Carried

By-laws - 3rd reading -

Moved by Aldermen Keen and LeBlanc that By-laws 050 to 053 incl. be taken as read a third time and finally passed. Carried

Notice of Motion - Moved by Aldermen Williamson and Lebano that the following Notices of Motion be received and placed on the agenda of June 13th -

that any member of Council using abusive language be immediately ejected from the Council Chambers.

that heavy trucks be prohibited on Ridgewood Drive.

New Business -

Moved by Aldermen Lebano and Samson that the administration obtain a cost factor for the taping of Council meetings for the purpose of retaining same as permanent records. Carried

Moved by Aldermen Guindon and LeBlanc that administration obtain a report on the cost of providing water services to Johnston and McKenzie Streets. Carried. It was indicated that the residents in these two areas would be willing to pay for the connection.



Moved by Aldermen Samson and LeBlanc that administration prepare a report on the request made by the Caisse Populaire at 8th and Pitt Street to pave the property to the City street limit. Carried

Moved by Aldermen Samson and Lebano that the transit manager consider and report on providing bus service to the MacDonell Memorial Hospital. Carried
