September 26, 1977

The Committee of Council met this evening with the following members present - His Worship Mayor G. Parisien; Aldermen R. Aubry, G. Cameron, F. Guindon, L. Keen, A. Lebano, A. LeBlanc, B. Lynch, G. Samson and Alderman G. Williamson. Aldermen Lavigne and Pescod were out of the City. Alderman Armstrong notified the Mayor that she would be unable to attend.

Adoption of Minutes -

Moved by Aldermen Lynch and Cameron that the Council minutes of the meeting of September 12th be approved. Carried

Moved by Aldermen Guindon and LeBlanc that the minutes of the Committee of Council meeting of September 12th be approved.Carried

Moved by Aldermen Samson and Aubry that the minutes of the Committee of Council meeting of September 19th be approved. Carried

Committee of the Whole -

Moved by Aldermen Keen and Lebano that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that committee and that by-laws Nos. 110 to 113 inclusive, as listed, be given a first reading -

Delegations -

Mr. Bill Ritchie presented a series of questions asking how a four to six year delay in submitting bills for local improvement work. He also requested an explanation as to how these liens were not registered in the Registry Office so that the local improvement levy would be picked up at the time a buyer is purchasing the property. Because of the abnormal delay in receiving local improvement bills the delegation requested that City Council allow an adjustment in the charge and, if that was not acceptable, the charge deferred for 20 years and that the interest be dropped. Mayor Parisien explained that in May 1976 City Council, upon being made aware of this situation requested that the administration indicate on the tax cards where local improvement charges were imposed or pending on the properties subject to local improvement levy. This decision of Council was not to include being registered at the Registry Office. The Local Improvement Act states clearly that local improvement charges are not a lien against the property and thus it is illegal to have this information included at the Registry Office. After some further discussion by different members of Council it was

Moved by Aldermen Guindon and Lebano that the request from the delegation be referred to administration and the administration meet with the City solicitor to review whether any remedial action would be taken and that a special meeting be held with those concerned to explain the City's position; also the Oct. 19th deadline for full payment of local improvement charges is to be delayed until a date following the special meeting with the delegation. Carried
