

February 28, 1977

LeBlanc, B. Lynch, J. Pescod, G. Samson and G. Williamson. Alderman Guindon was absent due to a previous commitment. Alderman Cameron was also absent.

Adoption of Minutes -

Moved by Alderman Pescod, seconded by Alderman Lynch that the minutes of the meeting of Council of February 14th be adopted as received. Carried

Moved by Alderman Keen, seconded by Alderman Lebano that the minutes of the Council meeting of February 14th be adopted as received. Carried

Moved by Alderman Samson, seconded by Alderman LeBlanc that the minutes of the Council meeting of February 17th be adopted as received. Carried

By-laws - 3rd reading -

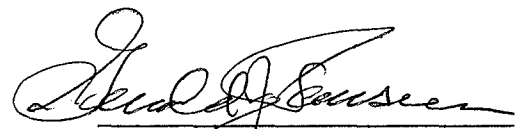
Moved by Alderman Lebrano, seconded by Alderman Keen that By-laws No. 019 to 023 incl. be taken as read a third time and finally passed. Carried

New Business -

1. Urban Development Plan - Moved by Alderman Aubry, seconded by Alderman Lynch that Administration set up a public meeting prior to April to discuss a report prepared by the Commissioners of Finance and Development in respect to a comprehensive Urban Development plan. Carried. Administration is also to invite briefs prepared by groups, organizations and individuals who wish to express their views on the said Urban plan.
2. Wintario Projects - Moved by Aldermen Lynch and Pescod that City Council remind the Minister of Culture and Recreation of the position the City of Cornwall had taken re criteria for Wintario proceeds. Carried. It was requested that Administration forward to the Ministry a copy of resolution #30-77 which was adopted at the Council meeting of February 25, 1976.
3. Ice Time - Moved by Aldermen Keen and Lebano that the Civic Complex manager contact Mr. Si Miller when he has finished booking the ice time for next season so that minor sports groups be given an opportunity to review the time available. Carried
4. Optimist Park - Moved by Aldermen Keen and LeBlanc that administration investigate the cost of upgrading the Optimist Park in order to provide same with a suitable baseball diamond. Carried
5. Services provided by consultants - Moved by Aldermen Lebano and Williams that Administration submit a detailed cost for services received from consultants in the year 1976. Carried
6. Trucks for snow removal - Moved by Aldermen Lebano and Lavigne that the Mayor and Administration arrange for a further meeting with the Independant Truckers Assoc. to review further problems which seem to arise by the use of a rotating leasing of trucks to be used for snow removal. Carried
