#### COUNCIL

The Chairman of the Committee of the Whole reported to Council the actions of the Committee including the second reading of the by-laws and recommendations for enactment.

#### Committee of the Whole -

Moved by Aldermen Pescod and Lebano that the Committee of the Whole be adopted. CARRIED

By-laws - 3rd reading - Moved by Aldermen LeBlanc and Samson that By-laws 148/77, 40, 61, 78 and 101 to 104 incl. and 106 to 110 incl. be taken as read a third time and finally passed. CARRIED

#### NEW BUSINESS

Bus Service - Transit Dept. is to be asked if it is possible to extend service along Vincent Massey Drive to Power Dam Drive.

Parking on Boulevards - The three by-laws relative to parking on City boulevards are to be reviewed by administration.

Le Village - Alderman LeBlanc agreed to bring up at the next meeting of LeVillage the problem of garbage left strewn along the streets; asking that all debris be placed out in time for the regular pick-up.

Bus Stops - Administration is to prepare a report on costs to pave the following areas used for bus stops - 2nd and Hoople; 2nd and Lefebvre; 2nd and Anthony and Pitt St. north at various intersections.

Committee Remuneration - Administration was asked to prepare a report on remuneration paid to members serving on various Boards, Committees, etc.

Traffic Control - A traffic count was requested at the intersection of Cumberland & 4th Streets.

Traffic Dept. was asked to consider the feasibility of removing the meters on the north side of 3rd St. between Pitt and Augustus Sts.


Swimming Pools - Costs are to be determined for keeping the pools open until the opening of school

Hiring Policy - Alderman Aubry notified Council that he will give Notice of Motion, at the next meeting, to have Council reconsider its decision of July 24th.

Ontario-Quebec border - Moved by Aldermen Pescod and Lebano that the Minister of Natural Resources be advised of Council's support to a resolution submitted by Cornwall Electric objecting to a proposed transfer to Quebec certain areas which have always been considered to be a part of Ontario. CARRIED

Mall Commission - Alderman Armstrong gave a verbal report on a meeting held August 10th. At this meeting, the suggestion was made that all sidewalks between 1st and 3rd St. on Pitt St. be resurfaced. At an estimated cost of \$50,000. the City is being asked to contribute an amount of \$33,000. Council declined this request.
