

CITY COUNCIL #22-79

July 9, 1979
7 p.m.

The Regular Meeting of Council was held this evening when the following members were present - Alderman G. Williamson, Acting Mayor, Aldermen D. Armstrong, R. Aubry, G. Cameron, F. Guindon, L. Keen, R. Lalonde, A. Lebano, A. LeBlanc, B. Lynch, J. Pescod and G. Samson. Mayor Parisien was away on vacation.

PRESENTATIONS

Certificates of Recognition were presented to the Canada Week Committee, Norman Lalonde, Theresa Lalonde, Norman Lalonde, Jr., Marcel Leroux, Joan Levy-Earle, Richard Marleau and Ginette Cayer.

Certificate and Pin were presented to Mr. W.L. Courville for 25 years of service with the municipality.

ADOPTION OF MINUTES

Moved by Aldermen Lynch and Lalonde that the minutes of the June 25th meeting of Council be adopted. Carried.

Moved by Aldermen LeBlanc and Lebano that the minutes of the June 25th Committee of Council meeting be adopted. Carried.

COMMITTEE OF THE WHOLE

Moved by Aldermen Pescod and Lalonde that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that committee and that by-laws 078 to 085 be given first reading -

- 079 - To appoint W.L. Moskowitz Director of Economic Development
- 080 - To authorize signing of Encroachment Agreement with Frank Ruffo, 517 Augustus St.

DELEGATIONS

S.D.&G. Humane Society - Ms. Jan Samis was designated as the spokesperson. The delegation indicated that it was unfair that this type of legislation was being approved by Council with no consideration accorded to dog owners and no input requested from the S.D.&G. Humane Society. She suggested that a proper method of formulating by-laws would be to appoint a special committee to look into solutions to a particular problem. As far as banning dogs in parks, three compromises were presented for Council's consideration - 1) stoop and scoop by-law; 2) providing for access to certain parks or certain areas in parks for dog owners to bring their dogs; or 3) a combination of the first two suggestions.

It was made clear to Council and the delegation that By-law 63, 1979 has been given three readings and is law. It was the consensus of Council that the presentation by the delegation and its suggestions be returned to Administration for consideration and that a further report be made available to Council. Until this matter is considered further, the by-law banning dogs from all City parks is to be enforced.

RESOLUTIONS

CONSENT AGENDA

- A. Ottawa Civic Hospital - Raffle Tickets
 Moved by Aldermen Cameron and LeBlanc that the Ottawa Civic Hospital be granted permission to sell raffle tickets in the City. Carried.

COMMUNICATIONS

- 1. Tax Adjustments - Moved by Aldermen Guindon and Lalonde that the tax adjustments for 1978 & 1979 as recommended by the Tax Collector be approved. Carried.
- 2. Tender #26-79 - Moved by Aldermen Pescod and Keen that the only tender bid received for the construction of a building addition to the refuse disposal site building not be accepted. Carried.

3. Tender #27-79 - Moved by Aldermen Cameron and LeBlanc that the bid of Laplante Farm Supply for a Kubota L245 DT tractor with snow blower at a price of \$10,500 and an extra snow blower unit McKee/Kubota 222K INDY at a price of \$2,280 be accepted for a total of \$12,780. Carried.
4. Tender #29-79 - Moved by Aldermen Samson and Cameron that the bid of Bingley Combustion Ltd. for supply and installation of natural gas heating plant for the Cornwall Community Arena at a price of \$9,835 be accepted. Carried.
5. Planning Board - Moved by Aldermen Pescod and Aubry that the minutes of June 27th be adopted. Carried.
6. Bell Canada Employee Petition - Moved by Aldermen Guindon and Lynch that cash-in-lieu for off-street parking be maintained and that parking restrictions on York Street be left in place. Carried.
7. Bicentennial Committee - Moved by Aldermen Lebano and Armstrong that the resolution contained in the minutes of June 29th be adopted. Carried.
8. Brookdale Sanitary Sewer - Moved by Aldermen Guindon and Lalonde that the section of sewer between Third and Fifth Streets be replaced along with existing services to the property line at an estimated cost of \$35,000. Carried.

COUNCIL

The Chairman of the Committee of the Whole reported to Council the actions of the Committee including the second reading of the by-laws and recommendations for enactment.

Committee of the Whole - Moved by Aldermen Pescod and Armstrong that the Committee of the Whole be adopted. Carried.

By-laws - Third Reading - Moved by Aldermen LeBlanc and Lynch that By-laws 078 to 085 as listed on the agenda for third reading be taken as read a third time and finally passed. Carried.


NEW OR UNFINISHED BUSINESS

Southeast Asian Refugees - Moved by Aldermen Lynch and Lalonde that Council request the Federal Government to increase the refugee quota and to speed up immigration procedures to allow quicker disposal of applications from the 'boat people'. Carried.

Newspaper Advertizing - Moved by Aldermen Lynch and Aubry that the practice of placing full-page ads in local newspapers with pictures of Council members be discontinued.

The motion was amended by Aldermen Cameron and Guindon to exclude promotional advertizing for the Dominion Day celebrations. The results of a recorded vote were as follows - For the Amendment: Aldermen Armstrong, Lebano, Lalonde, Cameron, Guindon, Samson and LeBlanc. Against the Motion: Aldermen Pescod, Keen, Lynch and Aubry. The amendment carried and the motion carried as amended.
