## DELEGATIONS

R.J.'s Teen Disco - R. Avon addressed Council and discloshis intention to operate a Teen Disco on the site of the former pool hall at 234 Pitt Street. He will cater to the 13 to 19 year age group with strict compliance to the rules and operate from 7 p.m. to midnight on Thursday and Friday and from 12 noon to 5 p.m. and 7 p.m. to 12 midnight on Saturday and Sunday. He tried a pilot project for a few weeks at the Seaway Motor Inn and was very successful and hopes he can make some contributio to the success of the Mall. He invited the Council to open house to see for themselves.

Mayor Parisien stated that he did not have to come to Council and wished him luck on his venture for the betterment of the Mall.

Ontario Humane Society - Mr. T.I. Hughes addressed Council and stated that all municipalities have problems with animals and hoped his Society could be of some assistance. The Humane Society has been involved for many years and can set up a system at a cost the City can afford. Mr. Hughes stated that he comes to us as an expert and the Society can provide a shelter in or near Cornwall and spread the costs among neighbouring municipalities. Mr. Hughes stated that chasing dogs and stoop and scoop by-laws do not work, He proposed a modern by-law directed at the dog owners which will eventually eliminate the problems. He asked to take this one stage further and meet a committee of Council for a full presentation on involvement.

Moved by Aldermen Williamson and Aubry that Administration meet with Mr. Hughes for a full presentation and report. Carried.
