

CITY COUNCIL - #4 - 79

January 22, 1979

The regular meeting of City Council was held today with the following members present - His Worship Mayor G. Parisien; Aldermen G. Williamson, R. Aubry, G. Cameron, F. Guindon, L. Keen, R. Lalonde, A. Lebano, A. LeBlanc, B. Lynch, J. Pescod, G. Samson. Alderman Armstrong was out of town all week.

Presentations -

A certificate and pin was presented to - Len Stanley, 30 years with the municipality; and Lucien Villeneuve, also 30 years; and Basil Stone 35 years.

Upon his retirement, after 35 years with the municipality, Earl Myers was presented with a watch and certificate.

Amendment to the motion by Aldermen Keen and Cameron that Sunday operations be closed at 12:01 a.m.

5. Police Vehicle - Moved by Aldermen Pescod and LeBlanc that the low bid of Cornwall Motor Sales, at a total cost of \$42,370. be accepted; and that existing cars be sold by public auction. - CARRIED


The chairman of the Committee of the Whole reported to Council the actions of the Committee including the second reading of the by-laws and recommendations for enactment.


Committee of the Whole - Moved by Aldermen LeBlanc and Guindon that the Committee of the Whole be adopted. CARRIED
