

CITY COUNCIL #32-79

October 29, 1979.

A Special Meeting of City Council was held this evening when the following members were present - His Worship Mayor G. Parisien, Aldermen D. Armstrong, R. Aubry, G. Cameron, F. Guindon, L. Keen, R. Lalonde, A. Lebano, A. LeBlanc, B. Lynch, J. Pescod, G. Samson and G. Williamson.

Gray's Creek Area - Moved by Aldermen Aubry and Lynch that this discussion and corresponding reports be dealt with in open Council.

An amendment was introduced by Aldermen Cameron and Lalonde that the matter be tabled to another meeting. The amendment was defeated.

Alderman Guindon requested a recorded vote on the motion. Aldermen Aubry and Lynch indicated that in light of confidential information obtained by the Chief Administrator, they would now not support the motion. The result of the recorded vote was as follows - For the Motion: Alderman Guindon. Against the Motion: Aldermen Armstrong, Aubry, Cameron, Keen, Lalonde, Lebano, LeBlanc, Lynch, Pescod, Samson and Williamson. Motion defeated.

Power Rate Increases - Moved by Aldermen Aubry and Pescod that the requests from Cornwall Electric and St. Lawrence Power Company to increase their rates by 9.5% be approved. Carried.
