Mr. Robert Bergeron indicated that he was representing Louis Bray Construction Ltd. and that in assessing the tender report presently before Council it is his client's opinion that he is submitting the lowest tender at a saving of approximately \$27,000. His client questions why a higher tender is being recommended. Because his client has not had sufficient time to review the figures presented in the report he is making a request that the tender be postponed in order to allow for a complete review of the recommendation

Mr. Knight advised that while it is known that most of the material will come from the Fly Creek project, it is not known at this time how much of that material will be suitable for the McConnell Avenue/CNR Grade Separation and as such the tender call could not ask for fixed prices. The firm of M.M. Dillon estimated the cost of this total job to be \$388,000 and again based on the firm's analysis, Louis Bray's bid was estimated at \$406,400 and Cornwall Gravel's bid at \$397,400. Therefore based on the analysis prepared by the consultants it was estimated that the lowest cost to the City was Cornwall Gravel's proposal.

Following further deliberations by members of Council, it was moved by Aldermen Leger and LeBlanc that this tender be returned to the Director of Engineering Services for clarification and that a further report and recommendation be presented to Council.
