It was further moved by Aldermen Pescod and LeBlanc that Rule 10 be invoked to allow members of Council to question Mr. Mallory, representative of Dodge Developments. Carried

Mr. Mallory indicated that this industrial mall is being labelled as a new breed in the industrial complex circles. He ventured that there were none like it between Montreal and Toronto. In answering questions from members of Council, Mr. Mallory stated that he did not expect his complex to take away any office users from the downtown area. Their needs are directly service-oriented office users, i.e., architects, industrial planners, etc. He further stated that Cornwall is the first municipality to impose office restrictions in the development of their complex.

Following the presentation by Mr. Mallory, Alderman Lebano requested a recorded vote on the amendment which resulted as follows -

entrance and exit. Carried


Menard Avenue - Moved by Aldermen Aubry and LeBlanc
