ADOPTION OF MINUTES

- Moved by Aldermen Lalonde and Samson that the minutes of the September 14th meeting of Council be adopted. Carried
- Moved by Aldermen Pescod and Guindon that the minutes of the September 14th meeting of Committee of Council be adopted. Carried
- Moved by Aldermen LeBano and LeBlanc that the minutes of the September 21st meeting of Committee of Council be adopted. Carried

Moved by Aldermen Samson and LeBlanc that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that Committee and that By-laws 167 to 171 be given first reading - Carried

1. Ontario Municipal Recreation Association Conference

Moved by Aldermen LeBlanc and Pescod that \$3,000 be allocated towards the 1983 conference of the Ontario Municipal Recreation Association and that this contribution be reflected in the 1982 budget of the Civic Complex. Carried

2. Township of Minto Resolution - Moved by Aldermen Guindon and Lalonde that Council endorse the resolution requesting that the Federal and Provincial governments provide, and/or force the Canada chartered banks and other authorized lending institutions to provide farmers and small businessmen with long term operating loans at reduced rates of interest. Carried
  3. Recreation Committee - Moved by Aldermen LeBlanc and Lalonde that the minutes of September 15th be adopted. Carried
  4. Tender #49-81 - Moved by Aldermen Guindon and Aubry that Item 1 of Purification Plant Energy Conservation Project be awarded to Alumicor Ltd. at a price of \$7,901 and that Item 2 be deleted and a more economical method be found. Carried
  5. Tender #50-81 - Moved by Aldermen Pescod and Lebano that the tender for Purification Plant Travelling Water Screen be awarded to FMC of Canada at a price of \$54,240. Carried
  6. Tender #60-81 - Moved by Aldermen Samson and Aubry that Items 5, 6, 7, 8, 9 and 10 for Fire Department Uniform Clothing be awarded to Harry Gore Industries at a total price of \$6,811.62 and that Additional requirements for 1982 be approved at a price of \$2,563.72. Carried
  7. Tender #68-81 - Moved by Aldermen LeBlanc and Guindon that the tender for the installation of 200 mm watermain on Cedar Rapids R-O-W from Brookdale to Pitt be awarded to Clarence McDonald Excavations at a total price of \$135,716. Carried
  8. Cumberland & Fourth - Moved by Aldermen Aubry and Pescod that steps not be taken to install either a traffic controlled signalized intersection or an all-stop intersection and that parking be prohibited on the west side of Cumberland from Fourth to a point 75 feet south. Carried
  9. Closure of Gunn Ave. - Moved by Aldermen Guindon and Leger that the portion of road allowance as shown on Schedule 'B' be closed and ownership transferred to the Roman Catholic Episcopal Corporation subject to the Corporation paying the survey and legal costs at no further compensation to the Municipality. Carried
  10. Landscaping Improvements Brookdale Rotary - Moved by Aldermen LeBlanc and Lalonde that a proposal from the Commissioner of Development in a report dated September 18th be approved for consideration during 1982 budget deliberations. Carried

- 11. 'The Diepper' - Moved by Aldermen Leger and Samson that Council contract to take 4 ads on the back cover of 'The Diepper' at \$250 per ad. Carried
- 12. Proposed Emergency Planning Legislation - Moved by Aldermen Pescod and Guindon that recommendations (a) and (b) from the Chief Administrator in a report dated September 24 be approved. Carried
- 13. Pedestrian Crossover Review - Moved by Aldermen Cameron and Lalonde that the report dated August 6th from the Traffic Engineer be tabled to the next meeting. Defeated  
 Moved by Aldermen Aubry and Samson that the report be adopted. Defeated
- 14. Second St. Parking Restrictions - Moved by Aldermen Pescod and Cameron that the matter be deferred to another meeting. Carried

Committee of the Whole - Moved by Aldermen Samson and Leger that Committee of the Whole be adopted. Carried


