- 5. Tender #70-81 - Moved by Aldermen Cameron and Samis that the tender for supply of winter highway coarse salt have a recorded vote which resulted as follows -

- 6. Removal of 1 On-Street Parking Space - Moved by Aldermen Cameron and Lalonde that one metered parking space be removed along east side of Pitt just north of Adam Avenue.

- 7. Possession of Alcoholic Beverages - Moved by Aldermen Aubry and Leger that by-laws be passed designating Civic Complex, Bob Turner Centre and Water Street Arena as places where possession of liquor is prohibited.

- 8. Planning Board - Moved by Aldermen Pescod and Guindon that the minutes of the September 30th meeting be received.

Carried

- 9. Planning Board No. 2 - Moved by Aldermen Pescod and Lebano that recommendations 1 and 2 in planning board report #2, dated September 30th, be approved and that recommendation 1 include the old and new definition for mobile homes.

Carried

A motion was made by Aldermen Pescod and Guindon that recommendation #3, on the report, be approved. The motion was voted on by recorded vote which resulted as follows..-

For the Motion: Aldermen Lebano, Lalonde, Guindon, Wise, Leger, Samson and LeBlanc.
Against the Motion: Aldermen Pescod, Cameron, Samis and Aubry.

- 10. Treasury Department Relocation - Moved by Aldermen Samson and LeBlanc that Council approve consolidation of Finance Dept.'s operations within City Hall & Justice Bldg. and renovations estimated at \$21,225.00.

- 11. Brookdale & 13th, No Left Turns - Moved by Aldermen Aubry and Pescod that additional advance symbolic sign be installed on the median and that regular police patrols be on lookout for infractions & follow through with tickets not just warnings.

Carried

- 12. Environmental Control Comm. Constitution - Moved by Aldermen Lalonde and Samis that the Environmental Control minutes be received and that the Environmental Control Comm. Constitution be approved as amended on the Chief Administrator's report dated October 9, 1981.

It was then moved by Aldermen Guindon and Lebano that Administration prepare a report on actions that could be taken to help alleviate the pigeon problem.

- 13. Second St. Parking Restrictions - Before Council considered the Administrator's report, Mayor Parisien asked that the Council add three other possible alternatives to the report, namely (C) That the present "no stopping" restrictions be retained and that all meters be removed, (D) That all "no stopping" restrictions and parking meters be removed from Amelia to York on Second St. (E) Remove all "no stopping" restrictions and retain meters on Second St. between Amelia and York Streets.

It was moved by Aldermen Wise and Leger that the "no stopping" restrictions be retained between the hours of 7:30 a.m. and 9:00 a.m. and 4:00 p.m. to 5:30 p.m.

A recorded vote resulted as follows -
For the Motion: Aldermen Lebano, Guindon, Wise, Leger and LeBlanc.
Against the Motion: Aldermen Pescod, Lalonde, Cameron, Samis, Samson and Aubry.

Defeated

It was then moved by Aldermen Aubry and Pescod that the existing "no stopping" restrictions be extended as follows - 7:30 a.m. to 9:00 a.m., 11:30 a.m. to 5:30 p.m., Mondays to Fridays, and at the same time remove all parking meters which would provide for unrestricted parking during those hours that the restriction was not in place. A recorded vote resulted as follows - For the Motion: Aldermen Pescod, Samis and Aubry. Against the Motion: Aldermen Lebano, Lalonde, Cameron, Guindon, Wise, Leger, Samson and LeBlanc.

Defeated

It was then moved by Aldermen Guindon and Wise that the "no stopping" restriction be removed on Second St. between Amelia and York Streets. A recorded vote resulted as follows - For the Motion: Aldermen Lebano, Guindon, Wise, Samson and LeBlanc. Against the Motion: Aldermen Pescod, Lalonde, Cameron, Samis, Leger and Aubry.

Defeated

It was moved by Aldermen Cameron and Lalonde that the present "no stopping" restriction be retained and that permanent signs be placed on the meter head detailing the "no stopping" restriction. A recorded vote resulted as follows - For the Motion - Aldermen Pescod, Lalonde, Cameron, Samis and Aubry. Against the Motion: Aldermen Lebano, Guindon, Wise, Leger, Samson and LeBlanc.

Defeated

It was moved by Aldermen Guindon and Samson that this matter be deferred to a subsequent meeting.

Defeated

As a result of the above noted actions Mayor Parisien ruled that Administration prepare a report listing all possible alternatives to this situation and that this matter be once again reviewed by Council.

Moved by Aldermen Lebano and Guindon that By-law No. 180 be taken as read a third time and finally passed.
