A Special Meeting of Council was held this afternoon when the following members were present - His Worship Mayor G. Parisien, Aldermen D. Armstrong, JR. Aubry, G. Cameron, F. Guindon, R. Lalonde, A. Lebano, A. LeBlanc, G. Leger, J. Pescod, J. Samis, G. Samson and W. Wise.

RECREATION & CULTURAL SERVICES

Parks

Moved by Aldermen LeBlanc and Lebano that the Parks Budget be approved. Carried

Parks (Community)

Moved by Aldermen Pescod and Lebano that \$16,000 for ski trail lights at Guindon Park be deleted. Carried

Moved by Aldermen Guindon and LeBlanc that \$3,300 for a boat launching ramp at Guindon Park be deleted. Carried

Moved by Aldermen Aubry and Pescod that \$2,500 be approved for the Silver Cross Park and Memorial Park cenotaph. Carried

Moved by Aldermen Lebano and Aubry that projects listed for Lamoureux Park at a cost of \$17,500 be approved. Carried

Moved by Aldermen Wise and Lalonde that the hiring of one supervisory personnel be deleted.

An amendment was moved by Aldermen Lalonde and LeBlanc that one supervisory personnel and one labourer be deleted and that \$5,000 be retained for part time help during the summer months. The amendment carried and the motion was defeated. Carried

Moved by Aldermen Aubry and Lalonde that the total Parks budget be approved as amended. Carried

Water Street Arena

Moved by Aldermen Guindon and Lalonde that the expenditure and income budget be approved. Carried

Bob Turner Arena

Moved by Aldermen Pescod and Lebano that the expenditure and income budget be approved. Carried

Kinsmen Building

Moved by Aldermen Guindon and Lebano that the expenditure and income budget be approved. Carried

Big Ben Ski Hill

Moved by Aldermen LeBlanc and Lalonde that the expenditure and income budget be approved. Carried

Recreation Services

Moved by Aldermen Guindon and Lebano that the expenditure and income budget be approved.

A first amendment was moved by Aldermen Wise and Samis that the Cornwall Braves request for \$2,100 be deleted. Defeated

A second amendment was moved by Aldermen Lebano and LeBlanc that the Cornwall Braves receive \$1,100 maximum. Carried

A third amendment was moved by Aldermen Wise and Cameron that Jeux Canada Games receive \$600. Carried

A fourth amendment was moved by Aldermen Wise and Leger that the request from Trinity Scouts for \$100 be deleted. Carried

The original motion was approved as amended.

Libraries

Moved by Aldermen Guindon and Samis that the budget be approved as presented.

An amendment was moved by Aldermen Cameron and Lalonde that the budget be reduced to \$247,380. The amendment was defeated when the vote resulted in a tie vote. The motion carried when Mayor Parisien voted in the affirmative to break a tie vote.

Other Cultural Activities

Moved by Aldermen Aubry and Pescod that this budget be approved. Carried

PLANNING & DEVELOPMENTPlanning & Zoning

Moved by Aldermen Aubry and Guindon that the expenditure and income budget be approved. Carried

Commercial & Industrial Development

Moved by Aldermen Wise and Lebano that the budget for the Director of Economic Development be approved at \$248,405. Carried

Moved by Aldermen Wise and Pescod that the Chamber of Commerce received \$35,500 and that the Seaway Valley Tourist Council receive \$9,250.

Carried

Moved by Aldermen Wise and Aubry that this budget be approved as amended.

Carried

Residential Development

Moved by Aldermen LeBano and LeBlanc that this budget set at \$40,217 be financed through the reserve fund and that it be deleted from this budget.

Carried

Planned Program Budgeting

Moved by Aldermen Aubry and Guindon that \$29,900 be added to the budget to implement this system as outlined in the CAO's report.

Carried

Aldermen Guindon asked to be excused from the meeting explaining that he had other commitments to attend to. He left at 7:15 p.m.


Mill Rate Increase
