

CITY COUNCIL #24-82

September 13, 1982.
7 p.m.

The Regular Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen R. Aubry, G. Cameron, F. Guindon, R. Lalonde, A. Lebano, A. LeBlanc, G. Leger, J. Samis, G. Samson and W. Wise. Alderman Armstrong was away on City business and Alderman Pescod was away on vacation.

ADOPTION OF MINUTES

Moved by Aldermen Lebano and LeBlanc that the motion for item #6 under Communications in the minutes of August 9th be amended to read "adopted" instead of "received". Carried

Moved by Aldermen Cameron and Lalonde that the minutes of the August 9th meeting of Council be adopted as amended. Carried

Moved by Aldermen Samson and Lebano that the minutes of the August 17th meeting of Council be adopted. Carried

DELEGATIONS

Cornwall & District Soccer Association - Mr. Dennis Carr introduced himself as the Past President of the Association. He indicated that the purpose of the presentation was to make Council aware of the lack of playing fields available to their Association. He further indicated that next year the problem would worsen in that La Citadelle High School will be resodding their playing field and the school grounds will not be available for play. He stated that the Association is requesting permission to make use of Jos St. Denis Field two evenings per week from 6 p.m. to 10 p.m. and on Sundays from 1:30 p.m. to 8 p.m., May to September. He suggested that, if Council is not able to grant this request, monies be allocated in next year's budget to provide the field for their use.

Mr. William Gray reiterated Mr. Carr's concern that next year the Association would not have adequate playing facilities. He noted that enrolment in soccer is accelerating at a remarkable pace and facilities will need to be available to accommodate all those wishing to participate in that sport.

Moved by Aldermen LeBlanc and Cameron that this matter be referred to the Recreation Committee for consideration.

Good Neighbour Services - Mrs. Mary Holt indicated that the organization had received grants in 1979-80-81 and her request now is that an amount equal to the taxes being paid be continued in 1982 and 1983. She stated that over the last 4 years she has employed approximately 20 people who were welfare recipients and are now off the welfare rolls. She added that her organization is registered as non-profit and also registered as a charitable organization. She indicated that her request for 1982 would be approximately \$13,000. In answer to questions from Council she advised that by the end of 1983 her organization should be self-sufficient and will look after its own needs.

Moved by Aldermen Samis and Lalonde that this request be referred to Administration for report for the meeting of September 27th. Carried

#26 - Moved by Aldermen Samson and Leger that the owners of the sign located on the south east corner of Power Dam Drive and Vincent Massey Drive advertizing "Cornwall Motel Area" be advised that the sign is in contra-vention to the City of Cornwall Signs By-law and that said sign must be made to comply with the by-law within 60 days of being notified and that should the owners fail to comply, the Chief Building Official shall proceed to take the necessary steps to have the sign removed. Carried

#27 - Moved by Aldermen Samis and Lalonde that Administration be required to prepare as soon as possible an updated report on the existing availability of sites for industrial development and that Council defer any decisions concerning expenditures toward development of a new industrial park until this report is discussed in Council.

Mr. King, representative of Blackwood Hodge Equipment Ltd. and Terex Machinery, informed Council that the equipment they had bid on was according to tender specifications. He felt that his equipment would service the municipality's needs adequately. Mr. Seguin, Director of Public Works, advised that the recommendation to accept the second lowest bidder was well explained in the report and could see no reason not to support the recommendation before Council.

After further consideration, it was moved by Aldermen Samson and Cameron that Tender No. 49 be deferred to the meeting of September 27th at which time a more comprehensive report will be presented to Council. Carried

- 3. Tender #52-82 - Moved by Aldermen Lalonde and Guindon that the tender for new electrical service at City Hall be awarded to Laurier Electric at a revised price of \$12,200. Defeated

Alderman Cameron asked to be excused from the meeting and left at 8:45 having to attend to business in Toronto.

- 4. Bicentennial Committee - Moved by Aldermen Lebano and Samson that the minutes of August 16th be received. Carried

- 5. Laws Dealing with Violent Crimes - Moved by Aldermen Lalonde and Lebano that Council support Petition 1 demanding a complete change in the laws dealing with violent crimes. Carried

- 6. Tender #50-82 - Moved by Aldermen LeBlanc and Lebano that the tender for wainter highway coarse salt be awarded to Domtar Chemicals at a total price of \$117,000. Carried

7. Leased Vehicles - Moved by Aldermen Aubry and Guindon that the leases on the 19 ½-ton trucks, 6 vans and the Ford Fairmont be extended for an additional two years and the lease on the Dodge Aspen be extended for one additional year. Carried
8. Leasing Proposals, City Equipment - Moved by aldermen Lebano and Leger that the proposal of the National Bank of Canada be accepted at a total leasing cost of \$437,507.64, with a purchase option of \$47,437.50 for a total deferred payment of \$484,945.14. Carried

10. Parking on First, Adolphus to Marlborough - Moved by Aldermen Aubry and Guindon that parking along the south side of First from Adolphus to Marlborough remain uncontrolled. Carried
11. Brodeur Street Truck Activity - Moved by Aldermen Guindon and Aubry that the Planning Dept. investigate the use of residential property for the carrying on of a trucking business. Carried

Treatment Facility for Hazardous Wastes - Moved by Aldermen Samis and Wise that Council strongly object to the Provincial Government concerning the possibility of locating a treatment facility for hazardous wastes near Cornwall or anywhere in Eastern Ontario. Carried

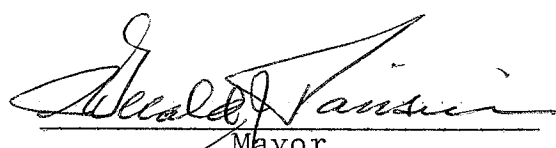
Industrial Development - Moved by Aldermen Wise and Leger that Administration prepare an updated report on the existing availability of sites for industrial development. Carried

No. 1 at Public Works Dept. at a total cost of approximately \$19,000. Carried
