Environmental Services (p. 10)

Moved by Aldermen Lebano and Pescod that Garbage Collection and Disposal Internal Transfers be reduced from \$780,000 to \$580,000.

Moved by Aldermen Pescod and Aubry that the sewage percentage on water bills be adjusted to maintain the present level of income which is set at \$615,000.


