

CITY COUNCIL #25-83

September 26, 1983.

The Regular Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen R. Aubry, F. Guindon, R. Lalonde, T. Lalonde, A. Lebano, A. LeBlanc, G. Leger, B. Lynch, E. Myers, J. Samis and W. Wise. Alderman Samson was absent due to illness.

At the request of Alderman R. Lalonde Council observed one minute of silence in memory of Osie Villeneuve who passed away.

ADOPTION OF MINUTES

Moved by Aldermen R. Lalonde and LeBlanc that the minutes of the September 12th meeting of City Council be adopted. Carried

Moved by Aldermen Leger and Lynch that the minutes of the September 12th meeting of Committee of Council be adopted. Carried

Moved by Aldermen LeBlanc and Lebano that Rule 10 be invoked to allow Mr. Harvey Kaddie 1643 McConnell Ave. to address Council under Delegations. Carried

DELEGATIONS

Use of Facilities at Complex - Mr. Rolland Vachon advised that he wished to rent a room at the Civic Complex to form the Christian Freedom Club. He would be willing to pay \$100 per month for the first 3 months and \$200 per month for the next 3 months, six nights a week. It was the consensus of Council that this request be referred to Administration for report.

King George Ball Park Situation - Mr. Reg Campbell indicated that he had a petition which includes 200 names asking that King George Park be retained for softball games. Mr. Ralph Gault indicated that this park had been in existence since 1937 and was now the heart of softball in Cornwall. He felt that Council was reacting to complaints initiated by three people and that shared usage of King George Park and Optimist Park could be worked out to the satisfaction of everyone concerned.

Moved by Aldermen Wise and T. Lalonde that senior softball be allowed at King George Park.

An amendment was moved by Aldermen Guindon and R. Lalonde that Administration prepare a report, based on the presentation made by Messrs. Campbell and Gault, for review by Council.

The amendment carried and the motion carried as amended.

Temporary Asphalt on McConnell Service Road - Mr. Harvey Kaddie presented a petition for temporary asphalt from 1617 to 1651 McConnell service road. He indicated that the municipality had paved the service road up to 1617 McConnell and would not go any further.

Moved by Aldermen LeBlanc and Lebano that the request be referred to the Engineering Department for report.

Moved by Aldermen LeBano and Wise that By-law 112 be taken as read a third time and finally passed.

NEW BUSINESS

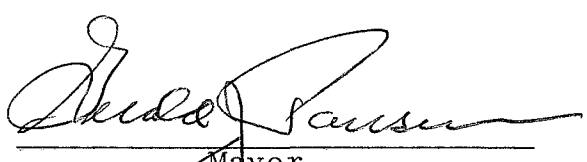
