COMMUNICATIONS

1. Power Rate Adjustments - Mr. Guilbeault of St. Lawrence Power and Messrs. Fairweather and Bradley of Cornwall Electric presented the reasons for their requests for power rate increases effective January 1, 1984.

Following their presentation and answers to questions from members of Council, it was moved by Aldermen Guindon and Wise that Council approve power rate revisions effective January 1, 1984 giving a general increase in revenue of 10.7% to Cornwall Electric and 11.6% to St. Lawrence Power.

16. Planning Advisory & Hearing Committee Report No. 1-2

Mr. Guy Willis indicated that he was representing 33 tenants residing at 308 Second Street East, which represents 25 units out of an 80-unit building. He requested that Council withhold approval of a conversion to condominiums and several reasons were given. He stated that many tenants had indicated that some pressure had been exerted on them to accept the condominium concept and many others were older residents who some time ago had decided to sell their homes so that they would not be burdened with ownership responsibilities. Others explained that the location of this building is excellent and if they were forced to move they may not find facilities as suitable as this one and perhaps these other properties would be substantially more Mr. Willis expressed further concern that no definite statement had been issued advising that the building was in a safe and sound condition. He also questioned a survey that had been made and suggested that perhaps the Council should consider having the Planning Department conduct its own independent survey. He concluded his remarks by stating that the decision Council will have to make is extremely important and that to convert this building to condominiums is not in the best interests of the tenants.

Mr. H. Dancause advised that he was appearing as a representative of Mr. G. Lalonde, owner of the property in question. He reminded Council that the Planning Department had recommended approval of Mr. Lalonde's application and that the Planning Advisory Committee had also supported the application. He indicated that, while this type of accommodation is new in Cornwall, it is not new in other cities and in fact has been well received. He suggested that this building is ideal for such accommodation in that it is situated

in an excellent area. Its structure and age are just right for this type of facility. He further indicated that his client was prepared to put in writing a guaranteed five-year lease or agreement for any tenant who wishes to not purchase his own unit. He concluded by suggesting that Council support the recommendation of the Phanning Department and the Planning Advisory Committee and approve the application before them.

Moved by Aldermen Aubry and Wise that an application for the conversion of 308 Second Street East to condominiums be supported with the following conditions:

- a) that the tenants as of the date of the conversion be guaranteed the right to remain as tenants for five years if they do not choose to purchase a condominium unit
- b) that the recommended repairs contained in the report prepared by M.S. Thompson & Associates Ltd. be undertaken.
