

CITY COUNCIL #3-84

January 23, 1984.
7:30 p.m.

The Regular Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen R. Aubry, F. Guindon, R. Lalonde, A. Lebrano, A. LeBlanc, G. Leger, B. Lynch, E. Myers, J. Pescod, J. Samis and W. Wise. Alderman T. Lalonde was absent due to being hospitalized.

This evening the prayer was offered by Mr. David Kaye.

PRESENTATION

Mrs. Yvette Claude and Mrs. Doria Nadeau, on behalf of l'Union Culturelle des Franco-Ontariennes (UCFO), presented a weaved mural of the Bicentennial Logo and granted the Bicentennial Committee the privilege of using the mural on occasions at their discretion.

ADOPTION OF MINUTES

Moved by Aldermen R. Lalonde and Lynch that the minutes of the January 9th meeting of City Council be adopted.	Carried

COMMITTEE OF THE WHOLE

Moved by Aldermen Pescod and Guindon that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that Committee and that by-laws 006 to 010 be given first reading -

- By-law 006 - To amend By-law 5/84 (Airport Commission)
 - 007 - To appoint lay persons to various committees
 - 008 - Directing & enacting the manner in which the interim levy shall be collected (Feb. 29, Mar. 30, Apr. 30)
 - 009 - To authorize the Mayor & Treasurer to borrow monies from time to time in amounts necessary to meet, until the taxes are collected, the current expenditures of the Corporation (up to \$25.5 million)
 - 010 - To authorize signing of encroachment agreement with Edgar Caza

RESOLUTIONS

#1-84 - Moved by Aldermen Lebano and R. Lalonde that this matter be deferred to the next meeting. Carried

#2-84 - Moved by Aldermen Lebano and LeBlanc that Council reconsider its decision to increase parking meter rates. Carried

A recorded vote resulted as follows -

For the Motion: Aldermen Lebano, Myers, Guindon, Samis, Wise, Leger and LeBlanc. Against the Motion: Mayor Parisien, Aldermen Lynch, R. Lalonde, Pescod and Aubry. The motion carried.

Following the motion to reconsider, it was moved by Aldermen LeBlanc and Lebano that Rule 10 be invoked in order to allow Mr. J.C. Lalonde, President of the Montreal Road BIA, to address Council. Carried

Mr. Lalonde indicated that he was representing approximately 100 store owners in the Montreal Road BIS and that a survey had been made on the Council's decision to increase parking meter rates and 100% of the store owners were opposed to the increase. He suggested that Council allow additional time in order for City Administration and the Montreal Road BIA to look for other options before a final decision is made.

A motion was introduced by Alderman Wise whereby the present meter rates remain the same and that some proportion of this rate structure be charged to the Downtown BIA as they seem to be responsible for the problem that Council is facing. There was no seconder.

It was moved by Aldermen LeBlanc and Guindon that the meter rates not be increased and that Administration meet with the Montreal Road BIA in order to work out a more viable solution. Defeated

It was then moved by Aldermen Wise and R. Lalonde that this matter be deferred until current budget deliberations. Carried

1. Airport Commission - Moved by Aldermen Leger and Myers that Phil Poirier be appointed to the Airport Commission for the years 1984-85-86, Alderman Guindon for the years 1984-85 and Paul Joncas for the year 1984. Carried
2. Heritage Cornwall - Moved by Aldermen Wise and Aubry that a request from Heritage Cornwall that Council reinstate a Council representative on the committee be filed. Carried
3. Heritage Village - Moved by Aldermen Guindon and LeBlanc that Cornwall participate in this year's Heritage Village and that Alderman T. Lalonde be designated as the coordinator. Carried
4. Lions Club - Moved by Aldermen Guindon and Lebano that permission be granted to hold a carnival from May 29 to June 3, 1984 at Brookdale Mall and that no other carnival of the same nature take place prior to this one, subject to provision of proof of liability. Carried
5. Marina 200 - Moved by Aldermen Guindon and LeBlanc that Marina 200 rent a minimum of 20 slips to a maximum 33% of total slips at \$300 for the boating season and that the slips be for boats not presently accommodated at existing local marinas. Carried
6. Legal Action, Convention Co-ordinator - Moved by Aldermen Wise and Aubry that a report from the Chief Administrator dated January 19th be filed and that Mr. Bhatnagar be so advised. Carried
7. Twinning - Moved by Aldermen Guindon and Lynch that Council supports the twinning of Cornwall with Cork, Ireland. Carried

third reading be taken as read a third time and
finally passed. Carried

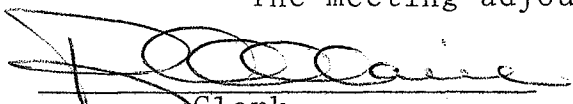
NEW BUSINESS
