ADOPTION OF MINUTES

Moved by Aldermen LeBlanc and Lynch that the minutes of the October 15th meeting of Council be adopted. Carried

Glen-Stor-Dun Lodge - Mr. Kevin Rivette is a volunteer worker at Glen-Stor-Dun Lodge. He expressed concern for the future of the Glen-Stor-Dun Lodge and indicated that he had questions he wished to ask Council, which were as follows - 1) what is the future of the Glen-Stor-Dun Lodge 2) what will the City do with the Lodge 3) why does the City want to move the Lodge 4) if the City wants to destroy the Lodge and build a new one on the same lot, why not leave it where the residents want it. After he had completed his presentation Mr. Rivette was advised that the City of Cornwall does not own the Lodge and has appointed a committee to review the possible relocation of this facility.

Moved by Aldermen Lebano and Samis that Mr. Rivette's delegation be referred to the City's Homes for the Aged Committee for Glen-Stor-Dun Lodge.

Taxi Restriction - Moved by Aldermen Samis and R. Lalonde that the Police Commission be requested to reconsider its restriction on taxi drivers which prohibits them from "doubling up" with several passengers who are going in the same direction and who are willing to split the cost. Carried


Parking on Daly - Moved by Aldermen Pescod and Lebano that Council request a report from Administration with recommendations to relieve the congestion caused by vehicles parked on both sides of Daly Avenue. Carried

CPR Relocation - Moved by Aldermen Lebano and Pescod that the Canadian Pacific Railway be asked to relocate their operations from Sixth Street and Amelia and that Administration cooperate with CPR to find a more suitable location as soon as possible. Carried


