CURRENT BUDGET

A Special Meeting of Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen R. Aubry, F. Guindon, R. Lalonde, T. Lalonde, A. LeBano, A. LeBlanc, G. Leger, B. Lynch, E. Myers, J. Pescod and J. Samis.

Public Works

Mr. Seguin, Director of Public Works, reviewed each component of his budget.

Alderman Wise joined the meeting at 7:35 p.m.

Public Works Projects

Moved by Aldermen R. Lalonde and LeBlanc that project #9, Public Works Yard, at a cost of \$7,200 be removed.

Carried

Garage & Yard Section

Moved by Aldermen LeBlanc and R. Lalonde that no action be taken on replacing department head cars until a report from the Chief Administrator is filed. Motion resulted in a tie vote with Mayor Parisien voting against the motion.

Defeated

Roads Section

Moved by Aldermen Wise and LeBlanc that his position of the budget be deferred until the transfer payments from the Province of Ontario are announced.

Withdrawn

Moved by Aldermen Samis and Lynch that the winter control component be reduced from \$727,228 to \$639,652 as per the Chief Administrator's report dated February 14th.

Carried

Moved by Aldermen LeBano and R. Lalonde that Asphalt Resurfacing be reduced from \$400,000 to \$200,000.

Carried

Sewer Section

After a lengthy discussion on the sewer lateral repairs it was moved by Aldermen Lynch and Aubry that the budget of \$200,916 be eliminated.

An amendment was moved by Aldermen Wise and Leger that the deductible paid by the property owner be increased from \$500 to \$1,000 except for the six lateral repairs started in 1984.

Alderman T. Lalonde moved an amendment to the amendment that the present deductible of \$500 be increased to \$525. There was no seconder.

The vote resulted on the amendment being defeated and the motion being defeated.

It was then moved by Aldermen LeBano and LeBlanc that the present policy be retained. Carried


Parking Section

Sewage Treatment


