ADOPTION OF MINUTES

Moved by Aldermen Leger and Carr that the minutes of the August 6th meeting of City Council be adopted. Carried

DELEGATIONS

Worldfest/Festimonde - Mr. Peter Minnelli, on behalf of Cornwall Worldfest Inc., presented a report on the final results of the 1986 Worldfest/Festimonde. He introduced his executive committee and advised that 1986 Worldfest was a success that exceeded their most optimistic hopes. He indicated that the success achieved was relative to four factors - work of volunteers (80), proper development of plans, involvement and support from all facets of our community and financial contributions received, particularly from the City of Cornwall. He went on to indicate that the publicity strategy was targeted for Cornwall and area and explained that it was their intention to restrict their efforts to the immediate area in order to sell the concept of Worldfest locally before any attempt was made to market the festival in Eastern Ontario. The marketing strategy also reflected the financial limitations contained in their operating budget. Mr. Minnelli thanked the City of Cornwall, the Provincial and Federal Governments and the private sector for their donations. He cautioned, however, that Worldfest is still in the infancy stage and in order for this event to grow, ongoing financial support from the three levels of government and the private sector are crucial. He estimated that 36,000 people attended the many Worldfest events and that at present an impact study is being prepared at no cost to Worldfest which study will estimate the economic contribution to our community. The Cornwall Worldfest is

now known around the world and has received praise from all performing groups. Mr. Minnelli advised that it is his organization's hope that Worldfest will continue to expand and grow at a pace that it can sustain. Planning is already underway for 1987 and the number of performances and attractions are expected to be moderately increased and promotion expanded in Eastern Ontario and Northern New York State.

Members of Council were very pleased with Mr. Minnelli's report and encouraged his committee to continue its excellent work.

- 4. Budget Supervisor - Moved by Aldermen Carr and Poirier that the position of Budget Supervisor within the Treasury function be refilled on a permanent basis. Carried

- 5. Economic Development Department Secretary - Moved by Aldermen Carr and Grant that the position of Secretary for the Department of Economic Development be refilled on a permanent basis. Carried
- 6. Tender #47-86 - Moved by Aldermen R. Lalonde and LeBlanc that the tender for waste management consultant operational progress reports for the refuse disposal site be awarded, subject to Ontario Municipal Board approval, to COMCOR at a total price of \$15,200 over a five year period. Carried
