DELEGATIONS

Mr. Lebano - Acquisition of St. Lawrence Power

Mr. Lebano commended City Council for its decision to acquire St. Lawrence Power. He indicated that the take over of this company would secure power supply in the future and would result in more economical rates. Mr. Lebano reminded Council that he was involved in the acquisition of Cornwall Electric in 1977 and that he spearheaded Council to acquire St. Lawrence Power. He personally felt that that this acquisition should have occurred three years ago. He cautioned however, that many citizens felt that the purchase price of \$13 million dollars too high and that the American interest are laughing all the way to the bank. Mr. Lebano further expressed concern that City Council and Cornwall Electric were using Ontario Hydro rates which are resulting in power rate increases in the order of 12 to 15 %. Mr. Lebano concluded his presentation by indicating that the decision to acquire St. Lawrence Power was a culmination of many hours of work in the past and that it certainly was in the best interest of our citizens and that he was pleased to have played a prominent part in this transaction.

Mr. Kevin J. Curry - Services and Accessibility of Cornwall Transit to communit

Mr. Curry addressed Council on the accessibility of bus tokens and bus passes. He indicated that as a user of the transit system, he would like to offer a proposal which he believes would improve the availability of tokens and passes to the systems ridership. He explained that currently bus tokens are only available at the Administrative offices and the Transport Canada Training Institute. He also indicated that bus passes and monthly renewals are only available at the Transit Administrative Office and periodically at City hall. His proposal basically is to provide bus passes and token renewals in various outlets throughout the municipality. The availability of these

passes and tokens would be extended beyond the normal office hours of the Administrative offices which hours often coincide with the riders working hours. He concluded his presentation by asking Council to endorse the Resolution to initiate the issuance of bus passes and tokens in various outlets throughout the city.

It was moved by Aldermen Guindon and LeBlanc that Mr. Curry's request be referred to Administration for report.

DELEGATIONS - Moved By Aldermen D. Aubry and T. Green

The purpose of those changes would be to improve the efficiency of the total one way system.
