A special meeting of City Council was held this evening when the following were present - His Worship Mayor B. Lynch, Aldermen D. Carr, C. Charlebois, B. Gallant, G. Grant, T. Green, F. Guindon, R. Lalonde, A. LeBlanc, G. Leger and C. Poirier. Absent were Aldermen T. Lalonde and R. Aubry.

Public Works

Moved by Aldermen R. Lalonde and LeBlanc that
Van #82 be deleted from the 1986 submission list. Carried

Moved by Aldermen Poirier and LeBlanc that the
motion of February 27th to delete equipment
#503 Zamboni be withdrawn. Carried

Industrial Waste

Moved by Aldermen R. Lalonde and LeBlanc that
the fee charged to industries be increased from
\$1 per load to \$4 per load. Defeated

Parks & Recreation

On a recommendation from the Director of Parks
and Recreation, it was moved by Aldermen LeBlanc
and Carr that the Summary Budget be reduced by
\$6,500 and that the revenue be increased by
\$30,000. Carried

It was moved by Aldermen Carr and Poirier that
the following ice rental rates be approved which
represent an increased revenue of \$5,000 for one
half of a season -

Skating parties	from \$50	to \$53
Daily ice rentals	from \$45	to \$48
Minor hockey (after 40 hrs.)	from \$35	to \$37
Minor hockey (first 40 hrs.)	from \$20	to \$21
Girls figure skating	from \$29	to \$30

Carried

Moved by Aldermen Carr and LeBlanc that the
purchase of computer and software in the amount
of \$15,000 be deleted. Carried

Pitt Street Mall

Alderman Gallant declared a conflict of interest as manager of the Downtown BIA and refrained from discussing or voting on this item.

Point of Privilege

Alderman Gallant explained that the purpose of the previous item was to discuss the Pitt Street Mall budget and not the Montreal Road BIA and the Downtown BIA. He further suggested that the discussion involving both BIA's could leave the impression that there is friction between the two groups when in fact there is complete co-operation.

Civic Complex

Moved by Aldermen Carr and Grant that the revenue from the Royals Hockey Club be increased by \$5,000 as per Mr. Upper's recommendation. Carried

Ice Rentals


After a lengthy discussion on this matter it was moved by Aldermen Green and Leger that the matter of Ice Rentals be deferred to the next budget meeting in order to allow the Complex Manager and Administration to present a more precise rental rate. Carried

Concerts


Moved by Aldermen Gallant and Green that the concert program be retained providing that the promoters who are willing to book the Civic Complex do so on a percentage basis after expenses. Carried

Moved by Aldermen Carr and Poirier that the motion be deferred until the Council has had an opportunity to review last year's concerts and related costs. Carried
