CURRENT BUDGET

DATE: February 1, 1988  
HOUR: 6:30 p.m.

The regular meeting of City council was held this evening when the following members were present: His Worship, Mayor Brian Lynch, Aldermen D. Aubry, T. Green, D. Carr, G. Leger, F. Guindon, C. Charlebois, R. Lalonde, B. Gallant, and T. Lalonde.

Aldermen Poirier, Leblanc and Grant were absent.

Civic Complex

As a result of a summer ice proposal and increased ice rental rates, it was moved by Aldermen T. Lalonde and R. Lalonde that revenue be increased by \$18,270.

It was moved by Aldermen Carr and T. Lalonde that the two security personnel be granted a full benefits package which represents \$1,500 increase in the budget.

It was moved by Aldermen Aubry and R. Lalonde that \$57,000 be added to the Asphalt Resurfacing Program and \$50,000 be added to the Sidewalk Reconstruction Program.

It was moved by Aldermen Aubry and Gallant that the concrete curb reconstruction program on Fourth Street from Pitt Street to Augustus at a cost of \$23,645 be deleted and replaced with Pitt Street improvement from First Street to Water Street at a cost of \$35,000.

MOTION DEFEATED 8-3


Budget Approval


