

CITY COUNCIL #25-89

October 10, 1989  
7:30 p.m.

The regular meeting of City Council was held this evening when the following members were present: His Worship Mayor Phil Poirier, Aldermen T. Green, C. Poirier, A. Lebano, A. Leblanc, T. Lalonde, G. Leger, D. Carr, F. Guindon, R. Lalonde and S. Backs.

PRESENTATIONS

1. Mr. Roger Jones of Fox Jones Associates - Report of Public Library Feasibility Study.

Mr. Dick Armstrong, Chairman of the Cornwall Public Library, indicated that the Library Feasibility Study was completed in January 1989, approved by the Board in February and then circulated to City Council. The purpose of this presentation is to re-familiarize Council with the study findings and offer recommendations.

Mr. Roger Jones, Fox Jones Associates, reviewed with Council an executive summary and recommendations which included identifying and prioritizing library service requirements, staff and space requirements. He noted that presently, library services are being offered from a collection of buildings that are ill suited for this purpose.

In response to questions on the financing of this facility Mr. Jones advised that a new library containing 25,000 square feet would cost approximately \$5 million with 1/3 funding from the province.

Mr. Jones concluded his presentation by stating that the Board supports long term option three to build a brand new, stand alone Public Library on a new site in the downtown or option four to build a brand new Public Library on a new site in conjunction with another public facility, such as the proposed aquatic centre, a multicultural centre, art gallery, or a new City Hall.

It was moved by Aldermen Lebano and Backs that the presentation be received and that the options offered be considered in the City's capital budget.

2. Hatch/Brofield Group - Spokesman Mr. Jim Dutfield on the I.C.I. Study.

Mr. J. Dutfield presented to Council the final report on Industrial, Commercial and Institutional Solid Waste Reduction Study. He stated that the goal was to better understand the generation and flow of wastes in the City by industrial, commercial and institution generators.

The objectives that the study met are:

- i) Identification of all ICI establishments, recording their solid waste types, weights, volumes, and disposal details; and
- ii) Development of a user-friendly computer waste information system. Features include data additions, deletions, queries, updates, and screen/printer output.
- iii) Assessment of the Recovery, Recycling, Reduction and Reuse potential of the solid waste materials currently entering the landfill, identifying potential markets and the best recovery methods.

Mayor Poirier thanked Mr. Dutfield for an excellent report and presentation.

3. Ontario Hydro / M.O.E. on PCB decontamination.

Mr. Doug Urban, District Manager, Cornwall District and Brian Casselman presented a slide display of how out of town PCB's would be transported, stored and destroyed using approved technology. Council was reminded that there are 51,000 litres of contaminated oils to be decontaminated at Hydro's CIL transformation station of which 32,000 litres would come from 12 remote stations.

Mr. Casselman completed his presentation by asking Council to reconsider its decision of September 25th, to not allow the transportation of PCB's from 12 outlying areas.

After questioning from members of Council, it was moved by Aldermen Guindon and Leger that Council reconsider its decision of September 25th of not allowing transportation of PCB's from the 12 outlying areas.

7. Cumberland St. between Eleventh & Thirteenth Streets 30.30.08

1. That Council direct Administration to prepare an amendment to the Traffic bylaw which will prohibit heavy vehicles from using Cumberland Street, between Eleventh Street and Thirteenth Street;

2. That Council direct Administration to bring back a final recommendation on the resurfacing of Cumberland Street, between Eleventh Street and Thirteenth Street, during current budget deliberations in 1991.
