

CITY COUNCIL #07-90

January 22, 1990
7:30 p.m.

The regular meeting of City Council was held this evening when the following members were present: His Worship, Mayor Phil Poirier; Aldermen T. Green, A. Leblanc, D. Carr, G. Leger, C. Poirier, F. Guindon, A. Lebano, R. Lalonde, T. Lalonde and S. Backs.

Also in attendance were the following Administrative Personnel: Mr. Hugh John Cook, Chief Administrative Officer, Mr. W. Knight, Director Planning and Engineering, Mr. H. Mayor Poirier recognized the 17th Cornwall Centre Boy Scouts led by Mr. George Sawinski and Mr. John Falardeau as group leaders. His Worship explained that these youngsters were in the process of earning their Citizenship Badge and the Mayor welcomed the group to City Council and presented each Scout with a city pin.

PRESENTATIONS

Mr. Bryan Merkley - Manager, S.D.G. Development Centre

Mr. Gilles Paradis introduced Mr. Bryan Merkley, Manager, S.D. & G. Business Development Centre. Mr. Paradis thanked Council for the opportunity to explain the services offered by the Centre. He indicated that the Centre was created in 1987 to assist small business' and entrepreneurs in the City of Cornwall. In 1988 the services were extended to the United Counties of Stormont, Dundas and Glengarry. He indicated that the BDC is fully funded by the Canada Employment & Immigration Commission under the Community Futures Program and operates as a non-profit corporation. The objective of this Centre is to stimulate business development within the counties to create employment opportunities.

The services of the BDC include business counselling, financial assistance, a business-oriented resource library and networking assistance to other business-related agencies. Mr. Paradis indicated that the Centre currently has over one hundred clients contacts per month with the majority of these clients being from Cornwall.

To date the Centre has loaned over \$350,000 to business within the counties and their target for 1990 is \$400,000. The Centre has calculated that the number of full-time jobs that are created or maintained by this lending function is approximately 125 jobs. The loans vary from \$3,000 for small contractors to \$62,000 loans for manufacturers. He indicated that the Centre is presently discussing equity participation with other business where the Centre's role could amount \$100,000. Under the Community Futures called Self-Employment Incentives, the Centre has created over 30 jobs in the United Counties with approximately 85% of these created in the City of Cornwall. Mr. Paradis completed his presentation by extending an invitation to City Council to visit the Centre and to remind Council that if it has any constituents interested in starting or expanding a business, to not be afraid to refer them to their service.

Mayor Poirier thanked Mr. Paradis for his presentation and involvement in the community.

It was moved by Aldermen G. Leger and T. Green that this New Business item be referred to Administration for a report. A recorded vote resulted as follows:

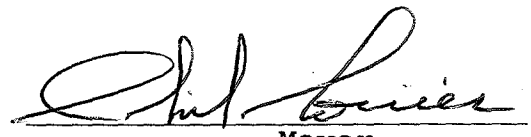
