9. Stormont-Glengarry-Cornwall Waste Management Master Plan

It was moved by Aldermen F. Guindon and D. Carr that Council approve the following:

- 1) That this report be approved and that the Steering Committee and the Consultant be advised of the following:
 - a) That the City is not in favour of participating in a Board of Management but would consider entering into an agreement with the Counties or a Board of Management for the managing and operating of a waste management system including the use of the City's landfill site.
 - b) That since the projected costs of the preferred system (wet/dry process) appear to be low, a breakdown of how these costs were derived be included in the final report.
 - c) That a two-tiered solution be considered under this program with the first stage utilizing the Blue Box system for the processing of recyclables and the second stage implementing the wet/dry system.
- 2) That the City of Cornwall continue to participate in the Waste Management Master Plan; and
- 3) That a copy of this report be forwarded to the Chairman of the Steering Committee and the consulting engineer firm, R. Cave and Associates.
