

CITY COUNCIL #29-90

November 13, 1990
7:30 p.m.

The regular meeting of Council was held with the following members present: His Worship Mayor Phil Poirier, Aldermen A. Lebano, G. Leger, T. Green, T. Lalonde, R. Lalonde, F. Guindon, A. LeBlanc, S. Backs and D. Carr.

Alderman C. Poirier indicated he would come to the meeting later in the evening.

PRESENTATIONS

1. Recognizing Youth in Government Day by the attendance of City Hall assigned students.

Mayor Poirier introduced some of the students attending the meeting who are participating with Youth in Government Day. He congratulated the Optimist Club for this endeavour and said he was looking forward to having these students spend half a day with senior staff learning about local government.

2. Operation of the Landfill Site - Gerry McKenna

Mr. McKenna presented a slide show on the status of the new landfill site and the closing of the former site. He indicated that a recycling centre will be in operation shortly.

3. Firefighters - Life Saving Exercise

Mayor Poirier expressed pleasure in acknowledging the heroic action taken by Platoon "A" who pulled a mother and her two children from a burning home on Sunday, November 4th.

The Mayor and Fire Chief Champagne praised the firefighters for the professional and team effort that resulted in three lives being saved. The platoon consists of Captain H. Graveley, Lieutenants R. Tourangeau and C. Dupuis, and firefighters A. Fraser, G. Ayotte, R. Cousins, S. O'Reilly, G. Clarke, P. Hamill and B. Cox.

DELEGATIONS1. Mr. Etienne St.Aubin -- LEGAL AID CLINIC / Montreal Road.

Mr. St. Aubin indicated that Council is being asked to consider the approval of an encroachment agreement in front of 26 Montreal Road in order to build an access ramp for disabled persons. This would provide access with ease and dignity to the legal advice and help of the Legal Clinic as well as medical services located in this building.

The two reasons brought forward by City staff to reject the request are wrong according to Mr. St. Aubin. He suggests that there is ample room for snow removal and sanding and secondly no one presently uses the rear entrance to the building as is being suggested.

After accepting questions from Council, it was indicated to the delegation that this matter would be discussed at Communication item no. 1.

2. Cornwall Builders Association - re By-law 163-1990

Mr. Richard Markell, President, expressed concern with the City's proposed By-law 163-1990, dealing with Site Plan Control. His association's concerns include the possibility that additional expenses will arise as a result of this legislation and possibly jeopardize construction and sales.

He concluded by asking that his association be given an opportunity to discuss this by-law with City staff being that the notice of hearing was not circulated to the membership after it had been received from the City. Mr. Markell was advised that this matter would be further discussed under Communications #8.

3. Cornwall and District Real Estate Board - By-law 163-1990

Mr. Terence Landon, President, supports good site planning but expressed concern that proposed By-law 163-1990, might impose controls for all sites and for all purposes. He indicated that, while legally, the City was not required to serve notice on his organization, that morally it should have been consulted before Council makes a final decision. He requested that this issue be deferred until his group and the builders association has had an opportunity to discuss the proposed by-law with City staff. Mr. Landon was also advised that this matter would be discussed under Communication #8.

It was moved by Aldermen A. LeBlanc and T. Green that Council defer this item until Administration has met with Mr. St. Aubin and Mr. Dubuc, proprietor, and report back to Council within one month.

2. Municipal Freedom of Information

It was moved by Aldermen T. Green and A. LeBano that City Council, delegate all powers and duties under the Municipal Freedom of Information and Protection of Privacy Act, 1989 to the City Clerk.

3. Tender #73-90 -Five (5) Public Transit Vehicles

It was moved by Aldermen T. Green and A. LeBlanc that the Allison VR731 retarder equipped transmission be deleted and replaced with a V731 transmission at a savings of \$4,029.00 per bus and that the Motorola radios be deleted and the radios in the existing buses be utilized for a saving of \$1,498.00 per bus for a total deduction of \$27,635.00 and that this tender be awarded to Motor Coach Industries Ltd at a revised bid price of \$1,133,285.00 all taxes included being the low and sole bidder meeting the tender specifications.

It was moved by Aldermen S. Backs and R. Lalonde that Council approve the tax write-offs as per the report dated October 23, 1990.

5. P.A.C. - 8-1 - Roger's Cable T.V.

It was moved by Aldermen F. Guindon and T. Green that:

(1) A parking lot for the operations of Roger's Cable T.V. and a one-storey office building measuring a maximum of 38 ft. from the westerly property line and occupying a maximum of 10% of the subject property, be permitted on property described as Part of Lot 14, South Sixth Street, being the westerly 90 ft. of the former Whitham Lawn Bowling property and;

(2) That a Temporary use by-law be passed, as permitted through section 38 of the Planning Act, to allow for the establishment, for a maximum of three years from the date of passing the by-law, of an equipment trailer as well as an office trailer to be occupied during construction.

6. P.A.C. 8-2 - R. Theoret

It was moved by Aldermen A. LeBlanc and R. Lalonde that a temporary use by-law be instituted to permit the continuation of an existing auto body and repair shop for an additional three year period in a Residential 20 zone located at 1610 Brookdale Avenue.

7. P.A.C. 8-3 - J & S Development

It was moved by Aldermen G. Leger and C. Poirier that:

(1) the application to rezone and redesignate the Glengarry Gates property to Community Commercial with certain exception, be denied; and

(2) that the highway commercial zone be further amended to permit a Pharmacy/Drug Store for this site.

8. P.A.C. 8-4 - Site Plan

It was moved by Aldermen T. Green and T. Lalonde that this item be deferred until a meeting is held between the Planning Department and the Cornwall Builders Association and the Cornwall & District Real Estate Board and a report presented to Council.

9. 911 Emergency Telephone Service

It was moved by Aldermen T. Lalonde and D. Carr that the Report from the Mayor's Task Force on the 911 Emergency Telephone Service for citizens of the City of Cornwall be referred to Budget Deliberations.

10. Ontario Heritage Foundation

It was moved by Aldermen A. Lebano and R. Lalonde that Council appoint Steve Alexander, Manager Planning Services, Gary Villeneuve from Heritage Cornwall and Aldermen A. Lebano and D. Carr with Aldermen F. Guindon and T. Green as alternatives, respectively, as per the letter from the Ministry of Culture and Communications to appoint representatives for the feasibility study of the Cornwall Capitol Theatre.

It was moved by Aldermen S. Backs and G. Leger that Council receive the letter from Police Commission Chairman, relative to enforcement of municipal by-laws.

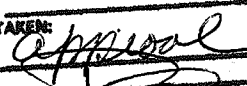
It was moved by Aldermen S. Backs and R. Lalonde that Administration prepare a report for Council on the costs of providing accessibility to the handicapped at City Hall.
