PRESENTATIONS

1. Ontario Winter Games, 1993

Mrs. Jill Proctor was recognized by Council for her role as Chairperson to the 1993 Ontario Winter Games held in Cornwall on March 10th to the 14th, 1993 inclusive. Mayor Martelle commended her and her organizing Committee for the outstanding work and reviews this community has received from across the province due to their Winter Games success. Mrs. Proctor was presented with a plaque on behalf of Council and the citizens of Cornwall, commemorating her remarkable efforts.

The Winter Games Organizing Committee were also recognized by Council and each member was given a City mug after which all members signed the Golden Book.

DELEGATIONS

1. PAC Report and By-law 053-1993

Mr. Garry Brunet spoke in favour of the P.A.C. report 3-1 regarding the Tourism Bureau which is to be voted on under Communication Item #6 of this evenings agenda. In view of the fact that a Supplementary report was included to the recommendation and that the report identified the possibility of allowing a temporary use to allow the Tourism Bureau to establish itself at 1300-1302 Second Street West, Mr. Brunet believed that this site was quite suitable for the intended use discussed this evening.

Mr. Brunet identified all main advantages to this site and encouraged Council to deal with the Site Selection under a re-zoning rather than a temporary use by-law.

Mayor Martelle thanked Mr. Brunet for his presentation.

2. Cornwall Chamber of Commerce

Mr. Denis Carr began his presentation by identifying the active role the Chamber played in the Tourism industry in the promotion of business and community development in undertaking economic programs, designed to strengthen and expand the income potential of all business.

Mr. Carr indicated that the Cornwall Waterfront Plan recommended that a visitors center be erected in Lamoureux Park in an effort to provide further services to the Community. The Chamber, seeking Council's approval, proposed to erect and operate a visitor's information center in Lamoureux Park for the months of May to September inclusive. The visitor's information center would in no way conflict with the Tourism Bureau, rather enhance its efforts in the economic prosperity of Cornwall and area.

It was moved by Aldermen Ray Lalonde and Chuck Charlebois that this matter be referred to Administration.

3. Let's Get Growing

It was moved by Aldermen Tom Green and Norm Lalonde that Clause 3 be amended to read "that Council provide a budget of no more than \$13,500.00 for this project in 1993 and that these funds be taken from the Waterfront Development Budget and that a report be submitted to Council by the Waterfront Development Committee identifying from which waterfront project these funds would come from."

1. Tradesmen & Contractors - Prohibit Out-of-Province
