5. **GLENGARRY BOULEVARD TRAFFIC CONDITIONS**

It was moved by Aldermen Chuck Charlebois and Terri Lalonde that traffic conditions on Glengarry Boulevard be reviewed as part of the recommended Transportation Study to be undertaken this fall and this review should include the suggestions made by the residents of the area, and that the issue of on-street parking on Glengarry Boulevard between Holy Cross Boulevard and Dundas Crescent South be included in this study.

6. **PEDESTRIAN CROSSOVERS - OVERHEAD FLASHERS & SIGNAGE**

It was moved by Aldermen Chuck Charlebois and Norm Lalonde that given pedestrian crossings in the Province of Ontario are regulated under the Highway Traffic Act and that changes to the signage and flashing beacons cannot be made by an individual municipality, efforts be made to increase driver and pedestrian awareness of the rules of the road through enforcement and education initiatives.

AND WHEREAS there appears to be vagueness regarding allocation of "Gratis" Cemetery lots as well as a clear budget for Funeral Homes.

NOW THEREFORE BE IT RESOLVED THAT the Department of Social Services submit a report to Council which will constitute an information statement as well as recommendations which might be used to formulate a policy on "Funerals for indigent residents".
