## COMMUNICATIONS

1. **Tender #3-1993 - Asphalt Resurfacing and Concrete Works**

It was moved by Aldermen Chuck Charlebois and Norm Lalonde that this tender be awarded to Dibblee Construction Ltd. at a total bid price of \$1,340,710.00 including taxes and being the low bidder meeting the tender specifications.

CARRIED

2. **Tender #15-1993 - Grass Cutting**

It was moved by Aldermen Aimé LeBlanc and Tom Green that this tender be awarded to Dale's Lawn Care Services at a total bid price of \$14.98 per hour including taxes, and not to exceed the budget figure of \$27,822.00.

3. **Tender #16-1993 - Leasing of two single axle trucks / workcrews  
Public Works Department**

It was moved by Aldermen Aimé LeBlanc and Brian Sylvester that this tender be awarded to Jack Warden Fuels Ltd. at \$42.15 per hour including taxes, for the first Truck and crew and \$42.15 per hour including taxes for the second Truck and crew and not to exceed the budget figure of \$36,910.00 being the low bidder meeting the tender specifications.

4. **Tender #17-1993 - Supply of Equipment & Crew for Restoration Work**

It was moved by Aldermen Chuck Charlebois and Norm Lalonde that this tender be awarded to Hec's Tree and Backhoe Service at a total bid price of \$206,039.20 including taxes, and being the low bidder meeting the tender specifications.

5. **Tender #20-1993** - Supply of one (1) Fire Rescue Truck.

It was moved by Aldermen Ray Lalonde and Norm Lalonde that this tender be awarded to Modern Mechanical at a total bid price of \$777,997.00 including taxes, and being the low bidder meeting the tender specifications.

11. **Tender #29-1993** - Tandem Truck with sideway dual dump box, Public Works Department

It was moved by Aldermen Angelo Lebano and Brian Sylvester that this tender be awarded to Fairview Garage under Plan #2 (with Trade-In) for a total bid price of \$92,852.05 including taxes and being the low bidder meeting the tender specifications.

12. Tender #30-1993 - Replacement of Evaporative Condenser at Bob Turner

It was moved by Aldermen Norm Lalonde and Aimé LeBlanc that this tender be awarded to Cimco Refrigeration at a total bid price of \$20,315.95 including taxes, being the low bidder meeting the tender specifications.

13. Tender #44-1992 - Supply of coarse winter salt.

It was moved by Aldermen Chuck Charlebois and Brian Sylvester that tender #44-1992, the supply of winter highway coarse salt which was awarded to Sifto Canada Inc. on October 13, 1992 at a total bid price of \$225,705.80 including taxes, now be extended to a total bid price of \$276,809.00.


