PRESENTATION

#1 - **Encore Seniors' Education Centre, St. Lawrence College:**

Mrs. Bev Hincks, Program Co-Ordinator of Encore; Seniors' Education Centre at St. Lawrence College and Mrs. Diane Raymond, President, attended City Council this evening to be recognized in having received two awards presented to them at a Conference held in Kansas City, Kansas, U.S.A.

They received an award for:

a) The CONNY for Best Program in 1994 from the Ontario Colleges Continuing Education Awards Competition

and b) The A.C.H.E. (Association for Continuing Higher Education Award for Outstanding New Program).

The Encore: Seniors' Education Centre is a new and unique program offering daytime, academic courses for Seniors' residing in the S. D. & G. Counties of Eastern Ontario.

DELEGATIONS

#1 - **S. D. & G. County Roman Catholic School Board and
S. D. & G. Public School Board.**

Mr. Joe Gunn, representative of the S.D. & G. Public School Board and Mr. Alex McDougall representative of the S. D. & G. Roman Catholic School Board were present this evening to speak on the matter of sidewalks in new subdivisions and the safety of our students.

Mr. Joe Gunn began by thanking Council and Administration for having asked their opinion and comments regarding safe pedestrian areas for students and the review of the Corporation's subdivision manual adopted by Council in 1990. Mr. Gunn indicated to Council that both Boards were concerned that the removal of sidewalk provisions represented a very dangerous precedent and further jeopardized the safety and well being of pedestrians and our students with the ongoing Provincial cutbacks in funding for School Boards, transportation policies may change which would see less busing and cause an increase in pedestrian traffic.

In conclusion, Mr. Gunn encouraged City Council to call on both Boards and seek out their advice to make judgement decisions that will not impede on the safety of students.

#2 **Cornwall City Soccer Club:**

Mr. Frank Marton, Tournament Chairman, made a presentation to City Council to inform them of the preparation being undertaken for the 20th Annual Indoor Soccer Tournament to be held between April 12th and April 21st, 1996. Mr. Marton continued to state the benefits to the local economy and reputation it created with our City.

During the 1995 tournament, Mr. Marton indicated that he had faced scheduling difficulties and was forced to make changes at the 11th hour. Although the Soccer Club was faced with team cancellations due to the re-scheduling he had received immense cooperation from City Administration and Council.

In conclusion, Mr. Marton asked Council and Administrative support to re-establish the long standing cooperation between the City's Parks and Recreation and this tournament.

It was moved by Aldermen Chuck Charlebois and Chris Savard that Mr. Marton's report be received and that Administration further explore scheduling or other alternatives in order that this tournament be successful in April of 1996.

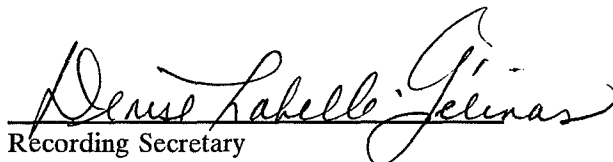
