1. JAZZ FESTIVAL

Resolution #22-1995

It was moved by Aldermen Claude Poirier and Brian Lynch that:

WHEREAS the Corporation of the City of Cornwall recognizes the Jazz Festival as a community festival; and

WHEREAS this festival encompasses all of the City of Cornwall and surrounding area.


NOW THEREFORE BE IT RESOLVED THAT the Corporation of the City of Cornwall supports the Jazz Festival, to take place from Saturday August 12th, 1995 to Saturday August 19th, 1995 inclusive subject to the following conditions being met:

- i) That the requesters hire Security Personnel to provide easy access for all Emergency Services, and to prevent customers from leaving lounges or patios with liquor, or prevent the public from consuming liquor on the street.
- ii) That the requesters supply Third Party Liability Insurance showing the City of Cornwall as additional named insured in a minimum amount of \$2,000,000.00.
- iii) That the requesters be responsible for all clean-up during and after the Festival.
- iv) That the requesters be responsible for the pick-up, installation, maintenance, and removal of necessary approved signage and all associated costs.
- v) That the requests be responsible for all costs associated with the advertisement or re-routing of City buses in conjunction with the Transit Department.


- vi) That the requesters submit a Letter of Credit or a cash deposit, fully refundable at the end of the Festival, in the amount of \$5,000.00 if all conditions and damages have been repaired to the satisfaction of the City of Cornwall.
- vii) That the Municipal Council may cancel its approval of these events if contravention to any of these provisions are not adhered to.
- viii) That all conditions noted by the Cornwall Downtown Business Improvement Association be met:
 - 1. Molson is and will be a major corporate sponsor.
 - 2. The licensed establishments bordering on Pitt Street are allowed to apply for patio licenses for the event, if they so desire.
 - 3. Pitt Street will remain open from midnight to 11:00 a.m. each day (service vehicles only).
 - 4. Continuous professional performances will occur daily from noon to approximately 10:30 p.m. on the mall.
