Mr. John Bolton stood before Council this evening to introduce a new non-profit organization within S.D. & G. known as *Gateway Riders*. Mr. Bolton indicated that this organization was born out of a strong commitment to youth, healthy living, recreational programming and a willingness to improve the quality of life for the people of Cornwall and S.D. & G. Several goals were identified and are being promoted by *Gateway Riders* as follows:

- Create in youth members self esteem in order to help them chart their life goals and defeat obstacles including unpopularity among peers, child poverty, and maltreatment of children as well as other obstacles which may diminish the self esteem of a minor.
- promote companionship among young members
- promote sportsmanship and a team spirit
- provide a source of commitment for members
- create healthy, responsible relationships between adult supervisors and trainers and young people of our area
- provide recreational activities for youth including young people whose families may be disadvantaged ; and
- provide activities that promote health and fitness of young people in the united counties area.

In closing, Mr. Bolton requested Council permission on the following matters:

permission to work with City programs to create a better cycling environment within the city
permission to work in concert with Parks and Recreation to develop cycle friendly programs on the bike path

- collaborate with City Planners to try to make Cornwall a more cycling friendly city
- permission to promote the bike path and to sell advertising for kilometre markers along the bike path within city limits
- assistance from the city with erecting these signs
- e assistance, in the form of services, from the city with Gateway Riders events along the bike path and in Lamoureux Park
- Office space and storage space at a city building for Gateway Riders
- assistance from the city in procuring funding from organizations such as the Trillium Foundation
- to maintain the path.
- assistance promoting Gateway Rider programs.

A. P.A.C. Report No. 6-1, June 18, 2001

Review of an application for a Zoning By-law Amendment and Official Plan Amendment to propose a full replacement of the existing Commercial 41 (COM41) zone of the City of Cornwall Comprehensive Zoning By-law No. 751-1969 as amended and a special O.P. Policy recognizing such zoning change in various affected areas, which have a range of designations. (P.A.C. File # 297)

- 1. That all the properties listed in Report # 2 Section A i.) be rezoned from Commercial 41 (COM 41) to the zones as identified accordingly in the June 14, 2001 staff report.
- 2. That a Special Official Plan Policy be incorporated by Official Plan Amendment to recognize the new replacement zones on the subject sites;
- 3. That all the subject sites listed above, except site 3b.) be subject to the Site Plan Control Process;
- 4. That nothing in this rezoning/OPA initiative is intended to relieve the relevant affected properties (landowners) from future negotiations to establish conditions for extending and then subsequent hooking into full Municipal services along Brookdale Avenue North; and
- 5. That following removal of the COM 41 zoning from the Comprehensive Zoning By-law, any reference(s) in the remaining text should be removed or modified accordingly.

B. **P.A.C. Report No. 6-2, June 18, 2001**

Review of an application for a Zoning By-law Amendment from Residential 20 (RES 20) zone to Residential 10 (RES 10) zone to permit single family dwellings only. The site is legally described as Block "O" and Part of Block "P", Registered Plan 322. The subject file is located south east of Lochiel Street and now known as the Pieria Court Subdivision. (P.A.C. File # 299)

That the subject lands be rezoned from "Residential 20" (RES 20) to "Residential 10" (RES 10) on Lots 1-15 in its entirety, Draft Plan 04-T-20011.

C. P.A.C. Report No. 6-3, June 18, 2001

Review of an application to consider the addition of "Call/Help Desk Centre uses" to various industrial/manufacturing zones including the Service Industrial (M.S.) Zone. This Amendment is intended to facilitate the development of such uses in a planned Industrial Park setting, in addition to areas that already permit such activities. This application is textual in nature only. (P.A.C. File # 300)

- 1. That the use referred to as, "Call/Help Desk Centre", be added as a permitted use to the Manufacturing 10 (MFR 10), Manufacturing 20 (MFR 20), Manufacturing 30 (MFR 30), Manufacturing 40 (MFR 40) and Service Industrial (M.S.) Zones and that a special Minimum Call Centre/Help Desk Office Space requirement of 25,000 sq. ft. be incorporated into the subject zones; and
- That notwithstanding anything else in this By-law, the following definition be added into <u>Section 01-1-1: Definitions</u> of the City of Cornwall Comprehensive Zoning By-law No. 751-1969 as amended:

"Call/Help Desk Centre" shall generally mean a building used, in whole or in part, to accommodate incoming and outgoing calls/ internet communication for the varied purpose(s) of sales, marketing, reservations, fundraising, customer service, technical support/assistance, help desk operations or other specialized (client specific) business activities. The operation is typically set-up as a large room with workstations that includes any combination of computers (internet), voice terminals (typically connected to an Automatic Call Distributor (ACD) system), video technology capability and one or more supervisor stations. A "Call/Help Desk Centre" may also be considered as a permitted use, under the "Business or Professional Office" heading in this By-law."

D. P.A.C., Report No. 6-4, June 18, 2001

Review of an application to amend Schedule 5: Transportation Plan of the Official Plan in conjunction with the proposed amendments of the Transportation Study. (P.A.C. File # 301)

- 1. That Schedule 5 be amended as recommended;
- 2. That Chapter 12 of the Official Plan Transportation Plan is proposed to be amended by adding the italicized words at the end of Section 17, to read as follows:

"Ensure that future development does not interfere with plans to extend or widen arterial, collector and local streets and that sufficient land is reserved for such improvements. Road widenings may be taken during Site Plan Control approval in order to achieve the optimum road right-of-way of 30 metres for arterial streets... and a width of 36 metres for Industrial Arterial Road and a width of 36 metres for any Divided Arterial Road."

E. **P.A.C. Report No. 6-5, June 18, 2001**

Review of an application for a Zoning By-law Amendment from Special Uses 20 (SPU 20) zone to Special Uses 20 (SPU 20) zone with a site-specific exception to permit the establishment of an Arts, Crafts, Antiques and Gifts Boutique on lands municipally described as 220 Second Street West, City of Cornwall. The property is situated on the south side of Second Street, midblock between York and Bedford Streets. It is also intended that a residential unit will be established on the second floor of the subject building as an ancillary use to the Boutique activity. (P.A.C. File # 302).

Council Compensation - Review year 2003
