### BUDGET MEETING #03

Tuesday February 27th, 2001  
Meeting began at 6:00 p.m.

#### **PRESENTATIONS**

Mayor Sylvester reconfirmed the proceedings that would be followed during the meeting of Budget deliberations in that he will entertain a maximum of three (3) questions per department from a member of council and then move to the next member of Council. Additional questions of Council will be entertained once all Council members have had an opportunity to address the floor.

Motions will be entertained to add or delete from the budget at any time, and as in past practice, Council may revisit any motion voted on. (No two thirds required)

Should a Council member wish an additional report from administration, Mayor Sylvester will entertain a motion directing administration to provide such a report to Council.

#### **PRESENTATIONS**

This evening Council heard Budget presentations on the following departmental divisions:

1. **Environmental Services**

  - c) Waste Services

#### **Sewer Surcharge**

It was moved by Councillors Andre Rivette and Claude Poirier that the Sanitary Sewer Rate be increased by 7% per household a year, which represents an increase of \$1.25 a month. This increase would render the utility as a self-funded entity.

## 2. Engineering Services

Moved by Councillors Dean Hollingsworth and Corey Kennedy that the Power Dam traffic signals capital project, in the amount of \$80,000, be re-inserted in the 2001 budget.

**AGAINST:** Councillors Don Deebank, Denis Carr, Naresh Bhargava and Mayor Brian Sylvester.

## 3. Progress Fund Interest

Moved by Councillors Andre Rivette and Perry Lalonde :

**WHEREAS** the 2001 capital budget includes the Renaissance project @ \$249,000 - the Waterfront projects at \$225,000 and the Medical Recruitment at \$100,000 for a total of \$574,000; and

**WHEREAS** these projects are to improve the quality of life in the community; and

**WHEREAS** these projects meet the criteria set out for the use of the interest from the progress fund;


**NOW THEREFORE BE IT RESOLVED** that these projects be taken out of the 2001 capital budget and funded from the interest from the progress fund; and

**FURTHERMORE** that Administration prepare a report which would identify if the Progress Fund has sufficient funds to cover these costs and that they further confirm that these projects meet the quality of life criteria's set forth on the use of the progress fund.


**Motion Carried**
