PRESENTATION

1. Economic Development Strategic Planning Study

Mr. Michael Williams of GGA Management Consultants appeared before Council to present the Economic Development Strategic Plan Study's plans and schedules.

In his presentation, Mr. Williams highlighted the many positive aspects the City of Cornwall already possesses in the area of economic development and praised its success in attracting significant new players to the City and thus lowering the unemployment rate. The Consultants' role is to prepare a practical report with a focus on a built-in process of participation which will lend itself to implementation in order to help further Cornwall's economic development initiatives.

Mr. Williams outlined three phases to the preparation of this report:

- Phase I - The Diagnostic Assessment Phase which is essentially a fact finding task expected to take from three to four weeks to complete.
- Phase II - The Opportunity and Strategy Identification Phase will involve the drafting of strategies and action plans. This phase is expected to take place in May 2002.
- Phase III involves finalizing the Economic Strategy and developing the Implementation Plan.

The final report is expected to be presented to Council in June 2002.

Mayor Brian Sylvester thanked Mr. Williams for his presentation.

D. Canada's Criminal Justice System

Moved by Councillors Donald Deebank and Syd Gardiner that Council support the City of Woodstock's resolution which supports the recommendations outlined in the Canadian Police Association fact sheet to have legislation enacted in order to strengthen Canada's system of sentencing, corrections, parole and release.

NEW BUSINESS

1. Handicap Parking Spaces

Moved by Councillors Perry Lalonde and André Rivette that:

Whereas there are people that show blatant disregard to handicap people by parking in handicap parking spaces without proper handicap stickers; and

Whereas this creates hardship for handicap people that have the proper sticker that need to use these areas; and

Whereas the City of Cornwall has a by-law in place to deal with this issue but the fines in place seems to have little effect on the abuse of this by-law;

Now therefore be it resolved that Council take the necessary action to deter this type of disregard for the handicap people of our community by changing the present by-law as follows:

1. That the fine for breaking this by-law be increased to \$300;
2. That the vertical signs in the handicap parking areas reflect the fine for parking in these area without a proper visible handicap sticker;
3. That the time limit for parking in a handicap parking is limited to three hours per visit; and
4. That the by-law enforcement department of the City be instructed to enforce this by-law with zero tolerance.

2. Project 2000

- Moved by Councillors Claude Poirier and Susan Carter that:

Whereas the City of Cornwall has indicated its support to construct an Aquatic Centre, Gymnasium and Curling Club as part of its Superbuild project; and

Whereas the Province of Ontario recently announced its share of funding for a pool and gymnasium but made no mention of the Curling Club; and

Whereas, in a press release dated March 2, 2002 from the Mayor's Office, the Mayor, the Chair of the Project 2000 Aquatic Centre Committee and the Chair of Cornwall Curling Club Building Committee stated the working meeting confirmed our commitment to work together to accomplish all three projects;

Now therefore be it resolved that we express to the Government of Ontario our hope that the agreement governing the Superbuild Fund and the City of Cornwall will permit us the flexibility to see all three projects completed.

- It was then moved by Councillors Denis Carr and Syd Gardiner to defer this matter until such time that the City has received a positive response from the Federal Government regarding its commitment to provide funds towards this project.

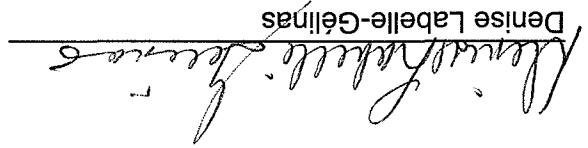
CONFIRMING BY-LAW
