Tax Study Comparisons

Moved by Councillors Denis Carr and Naresh Bhargava that Administration prepare a report that would illustrate costs for services provided and that would align our City with other municipalities to which we are compared with through the BMG tax study in order to bring our City on a more competitive level.

Moved by Councillors Dean Hollingsworth and Corey Kennedy that the Fire Pre-emption system be financed in the amount of \$60 thousand within the 2002 budget.

Moved by Councillors Andre Rivette and Claude Poirier that financing for one new vehicle (car 10) in the amount of \$30,000 be approved.

Moved by Councillors Andre Rivette and Claude Poirier that financing for a new vehicle (car 14) in the amount of \$30,000 be approved.

Fire Contribution to Reserves

Moved by Councillors Denis Carr and Perry Lalonde that Council approve \$100 thousand as contributions to Fire Reserves.

Motion Carried


Grader With Plow/Wing

Moved by Councillors Naresh Bhargava and Andre Rivette that Council approve the purchase of a new Grader with Plow / Wing for a cost of \$320 thousand less a transfer from reserves in the amount of \$40K resulting in a net cost of \$280 thousand dollars
