PRESENTATION

Project 2000

Mr. Rick Saaltink lead the presentation this evening and expressed their delight in presenting the schematics of the new proposed Aquatic Pool Centre. He continued to introduce the two main Architects working on this project. Messrs. Gerry Schoalts and Robert Goyeche with the firm of Rounthwaite, Dick & Hadley Architects in association with Schoalts & Zaback Arthitects.

Mr. Goyeche and Mr. Schoalts proceeded to detail the current stage of the Project and where they now take the program and convert it into a real image. He indicated that they presented a couple of design options and were instructed to complete their schematic design for alternate Design A and prepare a Class C estimate for the Aquatic Pool Centre. Additionally the Curling Club Committee were presented with two schematic designs for a stand-alone facility and as a result, RDH were instructed to finalize the schematic design based on the preferred design features from both designs presented and prepare a Class C estimate.

It was pointed out that the schematic design phase was on schedule and that RDH were developing their schematic design for the Aquatic Centre within the agreed 35,000 square feet parameter and expect that the Class C would be within budget. Additionally, the construction of a six sheet curling centre was still at risk even with a reduced areas specification for the building. Every effort is being made by the Project Team to bring the facility within budget.

In conclusion, Mayor Sylvester indicated that this matter would be further discussed and voted on under this evening's Communication portion of the Agenda.


