DISCLOSURES

Members of the Eastern Ontario Catholic School Board were invited to the meeting in order to discuss issues surrounding the construction of the proposed new catholic high school.

REPORTS ON NEW HIGH SCHOOL FOR THE EASTERN ONTARIO CATHOLIC SCHOOL BOARD

Mayor Brian Sylvester provided opening statements on the issue at hand and indicated, through a report prepared by the Chief Administrator that the appropriate approach to this issue would be for the Township/School Board to provide the City with evidence to the fact that the Ministry of Municipal Affairs and Housing has concluded that the proposed site can meet the various Provincial planning and environmental guidelines as was requested for the past number of months.

Should the provision of services be the only issue remaining to allow the Province to approve the site, with whatever site conditions it may be imposing, Council can consider the request for services on that basis. To discuss the provision of services without having the Province's position that the site does or can be configured to meet all Provincial guidelines would be premature. This is especially true when considering the fact that the City applied those same guidelines in raising its own objections to the OMB.

Mayor Sylvester continued to read that the only way to quickly resolve this issue may be to initiate a tripartite meeting between the Ministry of Municipal Affairs and Housing, the Township of South Glengarry and the City of Cornwall with the School Board invited as an interested party, if the MMAH permits it.

Chairman Ron Eamer then took the floor, with an extensive presentation of the School Board's position on the site selection and construction of the proposed new school. Chairman Eamer requested Council's support in helping them achieve their goal for September 2004 opening.

The School Board is seeking Council's conditional approval to provide them with the supply of water and sewer, on a revenue generated basis, which would help them meet one of the requirements under the compatibility study required by MMAH and at the same time save the Board \$40,000.00 by circumventing the hydrogeological survey required.

Following a comprehensive discussion and question period between Council members and the Board representatives, it was moved by Councillors Denis Carr and Perry Lalonde that:

BE IT RESOLVED THAT the City agree in principle to supply water only to the proposed new high school for the eastern Ontario Catholic School Board at a minimum of full cost recovery; and

That this agreement meet all of the various provincial planning and environmental guidelines set out by MMAH; and

BE IT FURTHER RESOLVED THAT their final agreement be subject to Council approval and that the Ministry confirm in writing to the City of Cornwall that the application meets zoning and provincial guidelines.

Succeeding additional discussion on the proposed motion, it was again moved by Councillors Denis Carr and Perry Lalonde that this motion be tabled to the Regular meeting of April 14th.

A recorded vote on tabling the motion resulted as follows:


