GENERAL CONSENT

ADOPTION OF MINUTES

The Minutes Regular Council Meeting #30 -2004 of Monday, September 27, 2004, were presented for adoption. There being no corrections noted, the Minutes stand approved and verified correct, as amended.

PRESENTATIONS

1. Certificate of Recognition of Saving a Life

Cindy Brandt, Coordinator of the ABHP (Associate Base Hospital Program) for Eastern Counties, provided a brief history of the services such as questions and answers and medical direction for Emergency Medical Services. They provide additional support and guidance to area police and fire departments.

Ms. Brandt commended the City of Cornwall in its role in making a commitment to the Chain of Survival in providing early access to Victims of Sudden Cardiac Arrest in Cornwall. This evening Ms. Brandt recognized several municipal employees who collectively saved five lives in 2003 due to their quick response and their use in providing CPR, defibrillation and other procedures.

Norm Barrette, Land Ambulance Division Manager, accepted an award presented by Ms. Brandt and Mayor Phil Poirier on behalf of the Paramedics who saved five lives in the community. On one of these occasions, the Fire Service contributed to the outcome of the patient. Following this presentation, Acting Lieutenant Pierre Baril and Firefighters Andrew Van Veen, Dominique Côté and Ian Butcher of the Cornwall Fire Department were recognized.

Priority would be given to Cornwall residents.
