### PRESENTATION

#### Manager of Finance

David Dick, Manager, Financial Services, provided a brief Power Point overview bringing Council members information on overall operational costs and what revenues are remaining for capital expenditures should the council wish to remain at a 0% tax rate increase. For the year 2004, it was indicated that the operational costs are presently identified at \$43,027,927 leaving \$3,399,407 for capital expenditures, should the council wish to maintain its overall budget for 2004 at 48,000,000.

Mr. Dick presented tax vs debt on a one time requirement for years 2004 to 2010 inclusive and again the same information provided should the Corporation Borrow \$5 million dollars to provide same services. A 0% tax rate based on a 2004 budget \$46,427,334 indicating operation costs at \$43,027,927 and Capital at \$3,399,407. Capital forecasts for 2004 at a 0% tax rate increase based on \$3,399,407 with expenditures of \$100,000 for Flooring GSDL, \$300,000 Medical Recruitment, Carry forward from 2003 to 2004 in the amount of \$120,000 Police Capital expenditures of \$227,683 leaving a 2004 allotment for project expenditures in the amount of \$2,892,000.

**At this point, Mayor Phil Poirier entertained a motion to move discussions to an In-Camera Meeting session to consider issues detailing contract negotiations with School Board pursuant to The Municipal Act, 2001, c. 25, s. 239(2).**
