## PRESENTATIONS

### 1. Medical Recruitment

Dr. Wilfred Chung, Co-Chair of the Mayor's Task Force on Medical Recruitment, came to Council this evening to report on medical recruitment for the City of Cornwall. This report summarizes community activities from 1990 - 2005 and illustrates both recruitment success along with demonstrating the need for continued support of this activity. Dr. Chung spoke about the challenge of acquiring physicians and the results of the Medical Recruitment Team.

The Recruitment Team participated in the week long PAIRO tour in September 2004 and the 2005 *Out of Quebec* tour, an event from which it has experienced success. It also retains close liaison with the Ministry's Community Development Office to take advantage of other initiatives focused on bringing additional physicians to the City of Cornwall. It participated in an event in Ottawa in early April, 2005 and will once again join the week long Tour in September, 2005.

In addition, the community acquired some positive exposure with a feature article about Cornwall's recruiting activities published in the PAIRO's 'Tour News, a publication electronically distributed to communities and appropriate government officials throughout the province.

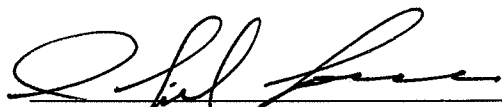
