## 1. Walk for ALS

Kimberly Walsh, Chair of Walk for ALS Cornwall,

Ms Walsh provided the Council a brief overview of Amyotrophic Lateral Sclerosis or as it is more commonly referred to Lou Gehrig's Disease. The disease is considered merciless and one which kills the nerves that control movement in the arms and legs as well as the muscles used for breathing. Essentially, ALS kills off one part of the body after another except for a person's mind and senses. The disease is always fatal and 90% of those diagnosed with ALS will die within one to five years.

In addition to the devastating physical toll that the disease takes, it also consumes a huge financial toll and one where people with ALS need a phenomenal amount of equipment.

Ms Walsh, as Chair of the 2006 ALS walk, encouraged all Council members , Administration and the Public at large to participate on Saturday June 10<sup>th</sup> in Cornwall's third annual walk for ALS, which will take place along the bike path at St. Lawrence College. The goal this year is to raise money for research and for the ALS Society's direct client services, including its equipment program, raise awareness and to educate the public about this ruthless disease.
